#### **POLICE MATTERS:**

#### • CHIEF BROPHY'S TIME RECORD

Chief Brophy presented his time sheet for the month of February 2010.

# **POLICE OFFICER VACANCY**

Chief Brophy indicated that filling this position would have a positive impact on the schedule and budget, specifically on the overtime and part-time officers' line and would enable them to maintain the School Resource Officer/Dare Program as well as providing an officer for the INTEL Program, with a savings of approximately \$22,000 per year. Additionally:

- o Salary for this position was budgeted for 2010.
- o Current list from Rockland County Personnel is certified until April 16<sup>th</sup>.
- This position is a replacement for a retired officer.
- Would recommend the following schedule:
  - March 9<sup>th</sup> meeting interview the candidate April 7<sup>th</sup> meeting nominate the candidate

  - This time frame would leave a month to get through Rockland County Personnel
  - May 12<sup>th</sup> meeting candidate could be appointed

It was decided that the candidate recommended by the Police Department would be interviewed at the March 9<sup>th</sup> meeting.

#### **DEPARTMENT OVER-TIME REPORT**

# **Zoning Amendments to Allow Emergency Services in Certain Locations within** the Town of Stony Point

- Town

#### **Cedar Pond Dry Hydrant**

David Zigler, a local surveyor, has existing maps and has kindly given them to the Town, eliminating the necessity of having additional survey work done.

#### RiverTowns of Rockland

# Reinstallation of Traffic Light at 9W/Lowland Hill

Dan Hogan of Hogan's Family Diner addressed the Board explaining that due to the location of his building, and what he feels to be safety issues, it would be beneficial to have the traffic light at Route 9W and Lowland Hill reinstalled.

After much discussion and since this is a state road, Councilman Finn agreed to contact the NYSDOT with this concern on behalf of Mr. Hogan.

## **Use of Facilities – Home Care Limited**

# **Bond Resolution for Capital Equipment**

<u>Supervisor Sherwood</u> explained that after review and research it was determined that bonding is a cheaper way to purchase needed equipment. Five year or less bonds would be handled as BANS. Under state law, prior to purchasing any equipment in this fashion for the sewer district, it is necessary to hold a public hearing, therefore, bond counsel has prepared the necessary paperwork.

# Resolution Establishing Standard Work Week/Day for Elected & Appointed Officials

This is to establish a standard workday for elected and appointed officials for retirement crediting purposes.

# Park Attendants (Recreation Facility Attendants)

Seasonal employees need to be hired to fill the positions of park attendants (recreation facility attendants).

# **GOLF COURSE – Halfway House**

<u>Supervisor Sherwood</u> indicated he has been working with the Director of Golf and Inn Credible Caterers regarding the proposed Halfway House (refreshment stand) at the golf course. When this project fell through last year, the Town returned the \$50,000 donated by Inn Credible Caterers for the project. They are now willing to build the refreshment

stand and run the sewer line to the building. The parks and highway departments will assist by providing the concrete pad for the structure. Inn Credible Caterers would like credit for the contribution to be deducted from the \$50,000 they are obligated to contribute for this project.

# **ACTION**

A motion was made by Councilwoman Konopko and seconded by Councilman White to authorize the Supervisor to amend the agreement with Inn Credible Caterers to allow them to directly purchase the refreshment stand and sewer line and be credited for their actual cost against the \$50,000 contribution they were obligated to make to the refreshment stand construction.
