PUBLIC INPUT

The following individuals spoke regarding the DARE and School Resource Officer Program at Farley Middle School:

Supervisor William Sherwood read the following:

Before we take public comment I want to deviate from the standard agenda.

As I greeted people tonight I found a number of you are present to support the Farley Middle School DARE program.

I had a chance to speak to Councilperson Konopko about the program and I am sure of her support for the program and while the other council members have not consulted with me I believe the support by this board for the DARE program is unanimous.

Everyone has some serious budget constraints and the town along with the school district have had to tighten our belts. The Chief has also been making every effort to keep his department's costs down but for the average homeowner I have to tell you that more than half of your town taxes go to support the police.

I had a lengthy conversation with Superintendent of Schools Dr. Ileana Eckert who has been struggling with her own budget issues. The devoted and caring teachers in our school district agreed to some substantial cutbacks to help the district save jobs and programs and as a result they succeeded in passing a scaled back but adequate school budget. I want to commend the teacher's unions for their selfless sacrifice in this difficult time.

The DARE program needs an officer for only about 20 days per school year. I am calling upon the PBA and patrol force of 22 or 23 officers in Stony Point to step forward in this crisis to benefit our town and save this program. If the teachers could do it I'm sure our police can do it.

All it will take is for each of our patrol officers to volunteer to work one additional day during the school year. That small effort for our community should make it possible to continue Officer Roberts, who has done such a great job with the DARE program, to be available for approximately 20 days to continue this very popular program.

Chief I am asking you to meet with your department and request on behalf of the taxpayers and citizens that we have here tonight that our patrolmen step up for the good of our children and give back just one day to free up Officer Roberts to continue her fine work in DARE.

Does anyone in this audience think that is too much to ask for our children?

SUPERVISOR'S REPORT

Supervisor Sherwood gave the following report:

We have had some good news since my last report and I will try to be brief but I do want you to know that our financial rating which is now A-1 and the efforts of this board have resulted in a very favorable auction rate on our paving bonds.

Our 15 year bonds came in at just 3.53%, a very favorable rate so we can go ahead with long delayed and long overdue paving work in the town. Tonight we'll be reviewing bids for that work which I am pleased to see came in well within the estimates we had for this work.

Even better the equipment Bond Anticipation Notes we sold went for an interest rate of just 1.147% with a coupon of 1.5%, a little less than the BANS we rolled over earlier this year. As you know our leases for equipment even on state bids were from 5 - 6%. We continue to look for ways to save and this board should be congratulated for its continuing efforts to save costs and increase revenues.

We have, with the finance director's help, been reviewing utility suppliers and we believe we can save some substantial money by changing suppliers, so be assured we are constantly trimming costs.

In that regard I will share two more bright spots. Our share of mortgage tax revenues has increased about \$25,000 so far this year over the same period last year.

And our increased revenues from the sale of our scrap metal since the new contractor (who is a local taxpayer) was brought in is up \$4300 over last year as of today.

FEMA has approved our request for reimbursement for the sewer line repairs and other cleanup caused by the spring flooding which cost just over \$100,000. The Federal Grant will pay 75% of the expenses and the state will pick up another 12.5% for a total reimbursement for this emergency project of 87.5%.

On other fronts the recreation department has issued at least 700 resident ID cards for our pool. I congratulate the board on offering the pool to our citizens for free this year. For comparison we had less than 50 family memberships last year so we are looking forward to a busy season when the pool opens June 26. I have not yet received a count on our wonderful and very economical day camp and recreation programs but I know that interest has been high.

Lowland Park is ready to go with the help and cooperation of the bridge contractors and our own maintenance department. On the first day of camp we will be rededicating the Park as Charles Eccher Park and unveiling a plaque to Mr. Eccher who ran the town's recreation program for so many years and put it on the path to be the success it is today.

The new shopping center building is moving ahead with great speed and we continue to hope it will be open for thanksgiving and that it will bring new life to the adjacent commercial areas that have become something of a blight.

I have seen positive signs of increased commercial activity and with the help of the Economic Development Advisory Committee and the Master Plan Committee I know we will be ready for some rapid commercial redevelopment in the coming months.

Fire Sub Station - Clarification of Planning Board Fees

No action necessary as this matter was rectified at the June 9, 2010 Workshop Meeting. For clarification, only the filing fee was waived, fees for outside consultants were not.

Bid - Collection of Scrap Metal

After discussion this matter was deferred to the July agenda.

Municipal Storm Water Pipe Relocation Project

Deputy Special Counsel Elizabeth Verrier reviewed the project:

- Part 3 of the Environment Assessment Form has been completed
- Negative Declaration no significant impacts
- Recommends acceptance

She further that at 3:45 pm today the Rockland County Drainage Agency sent the Town Clerk a fax indicating that they believe they have jurisdiction over the action that is occurring at this project, stating that the town had never responded to them when they had raised this issue in May of 2009. She pointed out her letter sent to them in August 2009 and the fact that they had not responded until today. Since there was not enough time to resolve this issue, the current resolution should be modified as follows: Section 3 should read subject to the resolution of jurisdictional issues raised by the Rockland County Drainage Agency and obtaining all permits as may be required for completion of the Project.

ACTION

A motion was made by Councilwoman Konopko and seconded by Councilman Finn to adopt the following resolution and negative declaration:

RESOLUTION ACCEPTING PART 3 OF THE ENVIRONMENTAL ASSESSMENT FORM AND

ISSUING A SEQRA NEGATIVE DECLARATION FOR THE HOLT DRIVE MUNICIPAL STORM WATER DRAINAGE PIPE PROJECT.

WHEREAS, a storm water drainage pipe presently located on the westerly portion of Holt Drive has severely deteriorated and can no longer function as needed; and

WHEREAS, this drainage pipe must be replaced and relocated to a location adjacent to the present drainage pipe site in order to properly manage the volume of water to be carried from areas surrounding Holt Drive and NY State Route 9W in the Town of Stony Point (the "Project"); and

WHEREAS, the body of wetland HC-3 is already impacted by the damaged pipe and will worsen in this condition; and

WHEREAS, an existing Town sanitary sewer line crossing the pipe may be threatened with undermining by continued use of this undersized storm drain; and

WHEREAS, no formally-listed threatened or endangered species were identified as occurring on the project area; and

WHEREAS, the proposed action consists of legislative action by the Town Board, New York State Department of Environmental Conservation, the United States Army Corps of Engineers and the New York State Department of State Coastal Zone Management, the agencies with approval jurisdiction over the proposed action; and

WHEREAS, the proposed action has been classified by the Town Board as an Unlisted Action, pursuant to SEQRA 6 NYCRR Part 617; and

WHEREAS, the Town Board has considered Parts 1, 2 and 3 of the Full Environmental Assessment Form (EAF), dated (last revised May 18, 2010), in which no significant environmental impacts were identified; and

WHEREAS, the Town Board has examined the Project in connection with the policies of the Local Waterfront Revitalization Program of the Town of Stony (LWRP) in accordance with General Town Law; and

WHEREAS, on May 18, 2010, the project was deemed consistent with LWRP per Robert Geneslaw Co., Planning and Development Consultants by stating "The proposed action will not result in the hindrance of any proposed uses or projects with the Coastal Area;" and

WHEREAS, the Town Board considered the proposed action at Town Board meetings held on July 14, 2009, April 13, 2010, and May 18, 2010, with a presentation regarding the project and its impacts being made by outside consultants to the Board and the public at the Town Board meeting held on April 13, 2010; and

WHEREAS, the Town Board has revised the proposed action to respond to significant comments from such agencies with jurisdiction; and

WHEREAS, the proposed action will not result in the impairment of the character or quality of important historical, archaeological, aesthetic resources or the existing character of the community or neighborhood; and

WHEREAS, the proposed action will not create substantial change in the use, or intensity of land including open space or recreational resources, or in its capacity to support existing uses; and

WHEREAS, the Town Board has considered reasonably related long-term, short-term, direct, indirect and cumulative impacts, including simultaneous or subsequent actions; and

NOW THEREFORE, it is resolved by the Town Board as follows:

<u>Section 1</u>. The Town Board accepts Part 3 of the Environmental Assessment Form as prepared and submitted on or about May 18, 2010.

<u>Section 2</u>. The proposed, Unlisted Action will not have a significant adverse effect on the environment and the Town Board hereby issues the attached Negative Declaration of Significance which is attached hereto in connection with the proposed Project.

Section 3. The application of the Town of Stony Point, to erect, maintain, alter or improve an existing storm water drainage pipe at Kay Fries Drive, Stony Point, New York 10980, is hereby APPROVED, subject to the resolution of jurisdictional issues raised by the Rockland County Drainage Agency and obtaining all permits as may be required for completion of the Project.

This Resolution will take effect immediately.

This notice is issued pursuant to the State Environmental Quality Review Act (SEQRA), Article 8 of the Environmental Conservation Law (ECL), and its implementing regulations, promulgated at Part 617 of the New York Code of Rules and Regulations (NYCRR) which collectively contain the requirements for the State Environmental Quality Review (SEQR) process.

The Town of Stony Point of New York, as lead agency, has determined the proposed action described below will not have a significant adverse effect on the environment and a Draft Environmental Impact Statement will not be prepared.

Title of Action: Town of Stony Point Municipal Pipe Re-construction

SEQR Status: Unlisted

Conditioned Negative Declaration: No

Description of Action: Replace and relocate an existing/damaged 240' by 36" diameter storm drainage pipe and out fall with a larger, adequately sized, drainage structure to an area east of the existing drainage pipe. The pipe installation will occur just east and parallel to the existing pipe. The reconstruction will result in impacting and eventually filling approximately 3,975 sq. ft. of wetland area (a wetland "peninsula") which extends south from the dominant northern wetland boundary of New York State Department of Environmental Conservation (NYSDEC) Wetland HS-3. The pipe is currently severely damaged at the out fall due to its under-sized design. The storm water's velocities discharging into NYSDEC Wetland HS-3 has eroded away the underlying and sidewall foundation of the existing pipe and, as a result, has severely damaged the pipe in multiple sections. Damage also has occurred further up the pipe as the concrete joints have eroded underground. A Town sanitary sewer line is in place above and perpendicular to the 36" storm drainage pipe.

The pipe's re-construction will start at the closest junction box, approximately 250' from the out fall pipe. The pipe will then take a 90 degree turn east and run approximately 60 feet where it will turn another 90 degrees north (where it will run parallel to the existing pipe) towards NYSDEC HS-3.

In order to service the storm water adequately, the pipe design will be much larger than the existing drainage structure. The proposed pipe is specified to start with 60" diameter sections and end with 120" diameter sections at the outfall to reduce velocities to a non-hazardous/damaging level as it discharges into NYSDEC Wetland HS-3. This may also be achieved by splitting the pipe into two or three 60" pipes next to each other. This will increase the footprint size and impact the smaller wetland peninsula located further east.

Also, proposed is a wetland buffer mitigation area to cut, grade, plant and monitor an area approximately 9,500 sq. ft. at the southeast area of Wetland HS-3 to mitigate for wetland fill.

Location: Town of Stony Point, Rockland County, New York

Reasons Supporting This Determination: The Town's drainage pipe is in major disrepair, particularly at the outfall portion of the pipe. The subject drainage pipe services a large storm water drainage shed that measures approximately 52 acres, which contains commercial/industrial and residential land uses. The 36 inch drainage pipe occurs as a damaged, undersized drainage pipe that is in need of re-design and reconstruction. In order to service the storm water adequately, the pipe design will be

much larger than the existing drainage structure. Since the existing pipe is located in a variable, man-made topography and secondary growth wetlands, impacts to the already-disturbed area will occur to repair/replace the Town's drainage pipe.

The following roll call vote was recorded and the motion was duly **adopted:**
