**CONTINUED PUBLIC HEARING-PROPOSED LOCAL LAW – FLOOD DAMAGE PREVENTION AS AMENDED TO REFLECT UPDATED FLOOD INSURANCE MAPS (FIRM) PANEL NUMBERS IN CHAPTER 112 OF THE TOWN CODE**

This continued public hearing was reopened at 7:35 pm by Supervisor Finn.

Special Counsel Brian Nugent advised that we need to amend the flood damage provision law we passed at the end of last year with respect to updating FEMA map panel numbers listed in the ordinance. We have received responses from the County of Rockland and the Stony Point Planning Board. The County deferred to the local board since it was just map numbers being changed and the Town recommended adoption.

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to close this public hearing.

**ADOPT LOCAL LAW NO. 1 OF 2014 - FLOOD DAMAGE PREVENTION AS AMENDED TO REFLECT UPDATED FLOOD INSURANCE MAPS (FIRM) PANEL NUMBERS IN CHAPTER 112 OF THE TOWN CODE**

A motion was made by Supervisor Finn, seconded by Councilman Monahan and **unanimously carried** by a voice vote of all board members present to adopt the following resolution:

**RESOLUTION AUTHORIZING ADOPTION BY THE TOWN BOARD OF THE TOWN OF STONY POINT OF LOCAL LAW NO. 1 OF 2014 TO AMEND LOCAL LAW NO.1 OF 2013 (“FLOOD DAMAGE PREVENTION - CHAPTER 112 OF THE TOWN CODE”)**

WHEREAS, following public hearings and comments on proposed Local Law No. 1 of 2013, the Town Board of the Town of Stony Point, on October 8, 2013, adopted such local law entitled **FLOOD DAMAGE PREVENTION** which repealed and replaced Chapter 112 (Flood Damage Prevention) of the Town’s Code, and

WHEREAS, new Flood Insurance Maps (FIRM) and Flood Insurance Study have been released by the Federal Emergency Management Agency (FEMA) requiring amendment to the local law to reflect the updated FIRM panel numbers in Chapter 112 of the Town Code and a public hearing, and

WHEREAS, notice of said public hearing was duly advertised in the Rockland County Times, the official newspaper of said Town, on **November 21, 2013** and copies of said proposed local law were made available to the public at the Town Clerk’s Office, and

WHEREAS, said public hearing was duly held on **November 26, 2013** at 7:00 P.M. at the Stony Point Community Center (Rho Building) and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Amended Local Law (or any part thereof) to amend the current Chapter 112 (Flood Damage Prevention) of the Town Code, and

WHEREAS, said public hearing was continued on **December 10, 2013** at 7:00 P.M. at the Stony Point Community Center (Rho Building) and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Amended Local Law (or any part thereof) to amend the current Chapter 112 (Flood Damage Prevention) of the Town Code, and

WHEREAS, said hearing was continued on **January 14, 2014** at 7:00 P.M. at the Stony Point Community Center (Rho Building) and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said Proposed Amended Local Law (or any part thereof) to amend the current Chapter 112 (Flood Damage Prevention) of the Town Code, and

WHEREAS, the Stony Point Planning Board on **December 16, 2013** reviewed the proposed Flood Damage Prevention Local Law and determined that the Planning Board recommended adoption of the Proposed Amended Local Law and had no objections to the Proposed Amended Local Law, and

WHEREAS, the Rockland County Department of Planning on **November 26, 2013**, having determined pursuant to Section 239-m of the General Municipal Law that the proposed local law amendments are to reflect the newer map panel information and flood insurance study information and accordingly the matter be remitted for local determination, and

WHEREAS, pursuant to part 617 of the implementing regulations pertaining to article 8 State Environmental Quality Review Act (SEQRA) it was previously determined by the Town Board of said Town that adoption of said Local Law was classified as an unlisted action, and

WHEREAS, upon review of a Short Form Environmental Assessment Form (EAF) the Town Board, on **September 10, 2013**, issued a negative declaration, determining that the proposed action will not have a significant effect on the environment and a Draft Environmental Impact Statement will not be prepared, and

WHEREAS, the amendment to the local law is limited to updating the map panel numbers as established by FEMA and accordingly not an action within the meaning of SEQRA, and

WHEREAS, the Town Board of the Town of Stony Point, after due deliberation, finds it in the best interest of said Town to adopt said Local Law.

NOW, THEREFORE, BE IT RESOLVED,

1. That the above WHEREAS clauses are incorporated herein by reference.
2. That the Town Board of the Town of Stony Point hereby adopts said amended Local Law No. 1 of 2014 entitled FLOOD DAMAGE PREVENTION, a copy of which is attached hereto and made a part of this resolution.
3. That such amended Local Law shall amend the current Flood Damage Prevention Local Law (Chapter 112 of the Town Code).
4. That such local law shall be effective immediately upon filing with the Secretary of State.
5. That the Town Clerk be and hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Stony Point, and to give due notice of the adoption of said Local Law to the Secretary of State of New York and the New York State Department of Environmental Conservation.

The Resolution was thereupon duly adopted.

### **MASS GATHERING PERMIT-POLAR PLUNGE 2014**

A motion was made by Supervisor Finn, seconded by Councilman Monahan and **unanimously carried** by a voice vote of all board members present to grant the Stony Point Seals permission to use the following parking lots to facilitate transportation of spectators to the annual Polar Plunge; Route 9W Commuter lot, Town Hall lot, lot adjacent to Town Hall, Clark Park and Riverfront Park. The board further issued a mass gathering permit for the Stony Point Seals, Inc. for their Polar Plunge fundraising event on February 2, 2014 in the area of the Grassy Point Seawall on River Road.

### **UNIFORM CONTRACT – HIGHWAY-SEWER-PARKS DEPTS.**

A motion was made by Councilman White, seconded by Councilman Monaghan and **carried** by a voice vote of all board members present (with Councilman Basile abstaining) to approve the Uniform Contract with American Wear for the same price as last year's contract.

### **RE-DEDICATION OF IRONWOOD COURT & YOUNGSTOWN COURT**

A motion was made by Councilman Basile, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present to approve the



Superintendent of Highway's request to **re-dedicate** Ironwood Court and Youngstown Court to the State Inventory List, as the State lost them off their inventory.

#### **LICENSE AGREEMENT – POLICE FIRING RANGE**

A motion was made by Supervisor Finn seconded by Councilman Monaghan and **unanimously carried** by a voice vote of those board members present to authorize Supervisor Finn to sign a License Agreement for the use of the Town of Ramapo Police Firing Range for calendar year 2014.

#### **SENIOR BUS TRANSPORTATION**

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to award the bid for senior bus transportation for February 1, 2014 thru January 31, 2015 in the amount of \$20,870.

#### **REQUEST TO INSTALL FENCING IN TOWN UTILITY EASEMENT**

#### **PYNGYP SCHOOL-CAPITAL IMPROVEMENTS**

A motion was made by Councilman White, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to approve the following resolution:

#### **RESOLUTION APPROVING A MAXIMUM OF \$25,000 FROM THE TOWN'S BUILDING AND FACILITIES IMPROVEMENT FUND FOR CAPITAL IMPROVEMENTS TO THE PYNGYP SCHOOL BUILDING**

The Town Board of the Town of Stony Point, duly convened in regular session, does hereby resolve as follows:

**SECTION 1.** That a maximum of **TWENTY-FIVE THOUSAND DOLLARS (\$25,000)** be used from the Town's Building and Facilities Improvement Fund for capital improvements to the Pyngyp School building, as listed on the attached "Schedule A," subject to approval of the Town Finance Director confirming that such improvements are authorized capital improvements within the meaning of applicable New York State statutes. The maximum amount set forth above shall include the cost of reconstruction of the Pyngyp School building foundation approved by Town Board on September 10, 2013.

**SECTION 2.** This resolution shall be subject to permissive referendum as permitted by law.

#### **PROPOSAL – SANITARY SEWER LINE REHABILITATION**

A motion was made by Councilman Basile, seconded by Supervisor Finn and **unanimously carried** by a voice vote of those board members present to accept the proposal for sanitary sewer line rehabilitation from Berger Engineering and Surveying in the amount of \$15,000, subject to review by special counsel of the proposal.

**RESOLUTION ACCEPTING AND ADOPTING THE FINDINGS AND RECOMMENDATIONS OF RICHARD K. ZUCKERMAN, ESQ., AS HEARING OFFICER, IN THE MATTER OF THE TERMINATION OR CONTINUATION OF STATUTORY BENEFITS PURSUANT TO GENERAL MUNICIPAL LAW § 207-c**

The Town Board of the Town of Stony Point, duly convened in regular session, does hereby resolve as follows:

**WHEREAS**, pursuant to notice dated September 12, 2012, an administrative hearing was held at Stony Point Police Headquarters on December 18, 2012, January 3, 2013, June 11, 2013 and June 19, 2013, before Richard K. Zuckerman, Esq., as Hearing Officer, to make findings and recommendations concerning whether statutory benefits paid to a member of the Town's Police Department pursuant to General Municipal Law § 207-c should continue or terminate; and

**WHEREAS**, after completion of a full evidentiary hearing and the submission of post-hearing briefs by Counsel for the Town and the member, the Hearing Officer has reported his Findings and Recommendations by written Decision dated January 6, 2014;

**NOW, THEREFORE**, upon reading the Findings and Recommendations of Richard K Zuckerman, Esq., as set forth in his Decision dated January 6, 2014, it is

**RESOLVED**, that the Town Board hereby accepts and adopts the Hearing Officer's Decision dated January 6, 2014, a copy of which has been provided to Counsel for the parties, and it is hereby further

**RESOLVED**, that prior to the receipt of the Hearing Officer's Decision, the member was granted a performance of duty disability retirement, effective December 19, 2013, pursuant to New York State Retirement and Social Security Law, and as a result, the member's 207-c benefits terminated pursuant to General Municipal Law § 207-c on December 19, 2013; and it is hereby further

**RESOLVED**, that to the extent that any such 207-c benefits are subsequently determined by any tribunal of binding and competent jurisdiction to have continued beyond December 19, 2013, that the Town Board hereby terminates the member's 207-c benefits based upon the Findings and Recommendations of the Hearing Officer and such determination shall be deemed retroactive to January 6, 2014, the date of the Decision of the Hearing Officer; and it is further

**RESOLVED**, that the Town Clerk will provide copies of the Town Board's determination to the member and the member's legal counsel, to the Chief of Police and to Special Counsel.

The Resolution was thereupon duly adopted.
