2. The amount of the refunds to be paid are approximately \$391.27 by the County of Rockland, \$3647.48 by the Town of Stony Point and \$11,474.71 by the North Rockland Central School District, for an approximate total of \$15, 513.46 without interest paid within sixty (60) days.

BID SENIOR BUS TRANSPORTATION

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to reject all bids regarding 2012 bus transportation for the Stony Point Senior Citizens and to authorize issuance of a new bid for a maximum two-year contract with additional specifications to be added to the new bid.

BID DRAINAGE IMPROVEMENTS-14 ZACHORY TAYLOR DR.

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to permit Environmental Construction to withdraw its bid due to an error. The Town Board rejected the remaining bids upon a reasonable belief that re-bidding will result in lower cost proposals on the Project.

BID KIRKBRIDE HALL-INSTALLATION THREE PHASE PAD MOUNT ANSFORMER

A motion was made by Councilman White, seconded by Councilman Finn and **unanimously carried** by a voice vote of all board members present to authorize the Town Clerk to advertise for bids for installation of a three phase pad mount transformer at Kirkbride Hall, once specifications are drawn for a fee not to exceed \$3,000.

BUDGET TRANSFERS

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to authorize the Finance Director to make budget transfers as necessary for closing the 2011 year.

ASSET VALUATION

A motion was made by Councilman White, seconded by Councilman Finn and **unanimously carried** by a voice vote of all board members present to authorize a contract for services in the amount of \$1,200 with Asset Works to provide updated depreciation schedules.

<u>APPOINTMENT - ZONING BOARD OF APPEALS</u>

A motion was made by Councilman Finn, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to reappoint James McDonnell to another five year term on the Zoning Board of Appeals, ending December 2016.

HEARING OFFICER-CSEA DISCIPLINARY HEARINGS

This item was put over to executive session.

AMENDMENT TO LICENSE AGREEMENT-INCREDIBLE CATERERS

A motion was made by Councilman White, seconded by Councilman Finn and unanimously carried by a voice vote of all board members present to authorize Supervisor Sherwood to sign an amendment to the license agreement with Incredible Caterers as on file with the Town. (The Amendment changes installation time of carpeting from every five years to every seven years and indicates it is the responsibility of the caterer to arrange the installation and purchase of the carpeting subject to the Town Board's approval of the price for it.)

SPECIAL SEGMENT RATE UPDATE

<u>Brian Nugent, Special Counsel</u> advised the Town Board that the Complaint, Notice of Petition and the Petition have been filed in Albany Supreme Court via an Order to Show Cause, which was signed by the Court. The Town must serve the papers on the State by December 19, 2011 and the Court set a return date of February 17, 2012.

A motion was made by Councilman Finn and seconded by Councilman Vicari to accept the fee arrangement with the firm of Feerick Lynch MacCartney with regard to the Special Segment Rate Issue. **THIS MATTER WAS TABLED TO THE JANUARY 10, 2012 MEETING.**

VOLUNTARY GRIEVANCE ARBITRATION

A motion was made by Councilman White, seconded by Councilwoman Konopko and unanimously carried by a voice vote of all board members present to authorize special counsel to proceed with selection of an arbitrator in PERB Case No. A2011-396.

AMBULANCE FUNDING

A motion was made by Councilman White, seconded by Councilman Finn and **carried** by a voice vote of those board members present (Supervisor Sherwood opposed) to withhold funding from the ambulance corp. until all issues are resolved with regard to renegotiating the contract and requested information is received concerning current cash balance and loan agreement for construction of the ambulance building.

COMPREHENSIVE MASTER PLAN

Robert Geneslaw, Town Planner was present and briefly recapped where this matter now stands. When the Draft Generic Environmental Impact Statement meets the Board's tensions, a Notice of Completion will need to be distributed. After discussion it was decided to table this item to the January 24, 2012 Town Board meeting for an opportunity for further review.

SPRUCE COTTAGE - REPORT

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to authorize the Supervisor to explore with the State DDSO the possibility of swapping the Spruce Cottage lease for other Stony Point property.

PHONE SYSTEM - JUSTICE COURT

A motion was made by Councilman Finn, seconded by Councilman Vicari and **unanimously carried** by a voice vote of all board members present to accept the proposal from Centurion Telephone S/S Inc. in the amount of \$4,900 for a new phone system for Justice Court.

<u>STREET LIGHT – 38 EAST MAIN ST.</u>

A motion was made by Councilman Finn, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to authorize the Superintendent of Highways to contact Orange & Rockland Utilities for a proposal for installation of a street light at 38 East Main Street.

WORKERS COMPENSATION INSURANCE-MUNICIPAL GROUP SELF-INSURANCE PROGRAM

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of all board members present to adopt the following resolution, subject to Special Counsel's approval:

RESOLUTION TO JOIN MUNICIPAL GROUP SELF-INSURANCE PROGRAM

WHEREAS, the Authorized Representative of the Town of Stony Point desires to secure the Town of Stony Point's obligation to provide volunteer firefighters' benefit law, volunteer ambulance workers' benefit law and workers' compensation benefits, as applicable through participation in a group self-insurance program of which the Town of Stony Point will be a member.

The Authorized Representative of the Town of Stony Point duly convened in regular session, does hereby resolve, pursuant to, and in accordance with the provisions of Section 50 of the New York State Workers Compensation Law and other applicable provisions of law and regulations there under as follows:

Section 1. The Authorized Representative (hereinafter "Representative") of the Town of Stony Point does hereby resolve to secure the Town of Stony Point's obligation to provide volunteer firefighters' benefit law, volunteer ambulance workers' benefit law and workers' compensation benefits, as applicable through participation in a group self-insurance plan of which the Town of Stony Point will be a member;

Section 2. The Authorized Representative of the Town of Stony Point does hereby resolve that the Town of Stony Point become a member of the Public Employer Risk Management Association, Inc., a workers' compensation group self-insurance program for local governments and other public employers and instrumentalities of the State of New York;

Section 3. In order to affect the Town of Stony Point's membership in said group self-insurance program, the authorized officer of the Town of Stony Point is hereby authorized to execute and enter into the Public Employer Risk Management Association Workers' Compensation Program Agreement, on file in the Office of the Town Clerk, on behalf of the Town of Stony Point.

Section 4. This Resolution shall take effect immediately.

EXECUTIVE SESSION

At 9:19 pm a motion was made by Councilman White, seconded by Councilman Vicari and **unanimously carried** by a voice vote of all board members present to adjourn into executive session to discuss personnel matters.

RECONVENE

A motion was made by Councilman Finn, seconded by Councilman Vicari and **unanimously carried** by a voice vote of all board members present to reconvene the December 13, 2011 Stony Point Town Board Meeting at 9:52 pm.

DISPLINARY ACTION

A motion was made by Supervisor Sherwood, seconded by Councilman Vicari and unanimously carried by a voice vote of all board members present to authorize Special Counsel to provide disciplinary charges under the CSEA Collective Bargaining agreement to be drafted and served on two employees and to withdraw Section 75 charges.

EXECUTIVE SESSION

A motion was made by Councilman White, seconded by Councilwoman Konopko and **unanimously carried** to adjourn the December 13, 2011 Stony Point Town Board meeting to executive session at 9:55 pm.
