STONY POINT TOWN BOARD MEETING – MAY 26, 2015

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, May 26, 2015 at 7:00 pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY. Supervisor Geoffrey Finn called the meeting to order and led the group in the Pledge of Allegiance. Town Clerk Joan Skinner called the following roll:

PUBLIC INPUT

<u>JoAnn Babcock</u> – spoke regarding the location of the proposed dog park indicating that the markings are no more than 100 ft. from her property line and brought up concerns she has about the park, including location of the park, noise, smell and disturbance to her family life.

<u>Councilman Basile</u> explained that the hours of operation, the length of time the park will be opened throughout the year, and also the rules & regulations for use of the park have not yet been established. The boundaries for the park have been moved back at least one hundred feet more from her property line and the "large dog" section will be even further away from her property. He indicated that there will be trees, landscaping and fencing to separate the two properties. He also invited Mrs. Babcock to join the planning committee.

<u>Susan Filgaris:</u> – Mott Farm Rd spoke about recent brush fires in West Haverstraw and Haverstraw caused by maintenance work on the CSX railroad and asked if the Town of Stony Point has any contact with or notification from CSX when work of this type is performed. She also thanked the PBA for helping to clear one of the old cemeteries in town.

<u>Mike Ehlers</u> – Jenkins Ave thanked the Supervisor for inviting the Skate Park Committee and PAL to participate in the Memorial Day Parade. The support from the public was wonderful.

<u>George Potanovic</u> - Old Gate Hill Rd. spoke in support of what Susan Filgaris said regarding CSX railroad and also about the transformer explosion and resulting oil spill at Indian Point Plant. He felt that it was necessary to have a better coordinated response between the County and the Town as well as with Indian Point. He also inquired as to the status of the Pyngyp School restoration.

- Tonight's meeting will be closed in loving memory of town resident, Joe Humphrey. Mr. Humphrey, a World War II veteran passed away on May 19, 2015. He has always been extremely community minded and assisted with many projects throughout the town, including designing the welcome to Stony Point signs and donation of his art works depicting the Battle of Stony Point.
- Special Counsel for the Town and Counsel for the PBA have been working on the RFP for design of the skate board park and hopefully it will be ready for release shortly.
- Recognized the fact that the battle of Iwo Jima took place seventy years ago.
- A bill is being sponsored by Assemblyman Skoufis, Assemblyman Zebrowski and Senator Larkin which would allow additional school tax relief in any district affected by loss of rateables such as a power plant.

CORRESPONDENCE

Joan Skinner Town Clerk read the following letter dated May 15th, from Siobhan Walsh, 10 Waldron Drive, Stony Point:

Re: Resurfacing Housing Development

Dear Mr. Brissing:

I have lived on Waldron Drive in Stony Point for twenty years and my development's roads were resurfaced shortly after I moved in. I know money is tight in most towns, however the streets in my development are a disgrace. I pay high taxes like everyone else in Stony Point, and after 20 years it is time to resurface, not patch these roads.

The potholes and cracks are so big I am afraid my car will be damaged when I drive home. I should not be afraid to walk in my neighborhood because I am nervous about twisting an ankle or tripping. Patching is no longer the answer here; the roads have just deteriorated too much. You would have to use so many patches on this development that it would create a huge tripping hazard in itself.

In short, I am hoping you inspect our development and agree that our roads are in desperate need for resurfacing.

<u>George Potanovic</u> - Old Gate Hill Rd spoke:

- Was a comparison made with other franchise agreements
- Does the franchise fee go into the general fund
 - It should be used toward improving communications with the public such as TV equipment, etc.

<u>Councilman Basile</u> asked that the Pyngyp School be placed on the list of public buildings eligible for free cable service.

Close Public Hearing

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to close this public hearing at 7:51 pm.

Approve Cable Franchise Agreement – Resolution 2015/28

A motion was made by Councilman Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present as follows:

RESOLVED, that:

1. The Town Board of the Town of Stony Point authorizes the Supervisor to execute the Franchise Agreement between the Town and Cablevision of Wappingers Falls, Inc., subject to approval of Town Special Counsel and Cablevision's legal counsel and subject to the inclusion of DVR service and the addition of the Pyngyp School as an additional Town Building to receive free cable service as discussed before the Town Board.

2. The Town Clerk as well as any other officers and employees are authorized to take any and all actions, as directed by the Supervisor, in order to carry out the purpose of this Resolution.

MS4 ANNUAL REPORT

John O'Rourke of Lance & Tully briefly reviewed the MS4 Annual Report for the period ending March 9, 2015 indicating that the report will be mailed tomorrow and the Town will be in compliance.

They have agreed to pay for any costs involved and must present the Town of Stony Point with a certificate of insurance for the event.

DOG PARK – AUTHORIZATION OF FUNDS

A motion was made by Councilman Basile, seconded by Councilman Monahan and **carried** by a voice vote of all board members present, with Supervisor Finn voting no, for the Town Board to authorize the Supervisor to submit a letter to DASNY confirming the Town's willingness to pay the \$2000 difference between the submitted budget for the construction of the Town Dog Park and the grant award of \$75,000.

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to adjourn into executive session at 8:11 pm to discuss personnel matters and legal matters. Supervisor Finn announced that no further votes would be taken.
