CHAIRMAN JOHNSON: All right. Next on the agenda is Tyler Place.

MS. RAMANATHAN: Hello. Good evening. CHAIRMAN JOHNSON: How are you?

MS. RAMANATHAN: I'm good. Ramya
Ramanathan from Atzl, Nasher and Zigler, New City, New York.

So we're here for the Tyler Place subdivision project. And just an update from the last time we were here in front of the Planning Board, we've gone to the ZBA. We've requested for the variances. We've had a public hearing with the ZBA, which is now closed. But we won't get the variances until the SEQR process has been resolved with the Planning Board. And we're still yet to have a public hearing with this Board, so we'd request to set one up for that as well. So that's basically why we're here today.

CHAIRMAN JOHNSON: All right. Do we need to accept the Part 2 before we set the public hearing?

MR. STACH: Yeah. Not before you can do it. You don't have to do that.

MR. STACH: Yeah. So the actions you've taken so far are that you've noticed your intent to declare lead agency, and you tentatively classified the action as Type I. So what I'd recommend is tonight, that you formally assume lead agency status, classify as a Type I action, and adopt the EAF Part 2.

I provided and recommended one that identifies three impacts. One is impacts from land disturbance. There are steep slopes, and the applicant is proposing construction over more than 15 months.

Impact on ground water. This is a little bit, sort of complex. But I'm asking them to address the fact that their previous plans to extend the water main beyond the end of Kennedy Drive could be foreclosed by this project. I understand that. And we discussed this at the TAC meeting. And I think they've agreed to provide easements that would allow the extension of the water main across this property if necessary. So, but $I$ would like them to address it in the Part 3.

CHAIRMAN JOHNSON: Okay.
MR. STACH: And then the third is this
is an area that is noted as a potential
habitat for northern long-eared bat, which usually just requires clearance of trees after November 1st and before April 1st.

So those are the three impacts I
identified. If you agree, you could
identify -- you could adopt that Part 2 as well. So it's lead agency, Type I action, Part 2.

CHAIRMAN JOHNSON: I make a motion to declare lead agency. I need a second.

BOARD MEMBER ROGERS: I'll second that, Mr. Chairman.

CHAIRMAN JOHNSON: I got a motion and a second. All in favor?
