NOTICE IS HEREBY GIVEN that a Public Hearing will be held by the Town Board of the Town of Stony Point, Rockland County, New York, on November 22, 2016 at 7:00 PM at Rho Building, 5 Clubhouse Lane, Stony Point, New York for the following matter:

AMENDMENT TO TOWN CODE, CHAPTER 215, ARTICLE IX (SIGNS)

The Town Board for the Town of Stony Point is considering amending the Town Code, Chapter 215 Article IX, adding a new section that would allow the use of LED signs on parcels occupied by emergency and/or public services organizations.

The full text of the proposed Local Law will be on file in the Town Clerk's Office, 74 East Main Street, Stony Point, New York, no later than November 14, 2016 and may be obtained by any interested parties from 8:30 am to 4:00 pm, Monday through Friday.

<u>Special Counsel</u>, <u>Brian Nugent</u>, addressed the Board advising that a proposed resolution has been drawn to declare the Town Board as lead agency with respect to the environmental review of this local law. There is also a change in the format of the local law; however the substance remains the same. There was an error in the original draft that indicated that this was a SEQRA Type II action; it is not, it's an unlisted action. For public hearing purposes the substance of the law will be the same for comments and review.

The draft local law was sent on November 15th to the Rockland County Planning Board and the Stony Point Planning Board for their comments. They have 30 days to respond.

ACTION

A motion was made by Supervisor Monaghan, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present to adopt the following resolution:

RESOLUTION OF THE TOWN BOARD FOR THE TOWN FO STONY POINT, NEW YORK DECLARING ITSELF LEAD AGENCY UNDER THE STATE ENVIRONMENTAL QUALITY REVIEW ACT AND DETERMINING THE SIGNIFICANCE OF THE ACTION

WHEREAS, the Town Board for the Town of Stony Point ("Town Board") seeks to adopt a proposed Local Law to amend Chapter 215, Article IX of the Town of Stony Point Town Code entitled Signs Law of the Town of Stony Point to allow emergency and governmental service organizations such as ambulance corps, and fire and police departments to install and use LED signs for the purpose of publishing and posting messages to inform the public of emergency situations; and

WHEREAS, the proposed Local Law is an amendment to a use in the Town Zoning Code affecting less than twenty-five (25) acres, and is thereby determined to be an Unlisted action; and

WHEREAS, the Town Board is sole agency involved in the consideration of the proposed Local Law; and

WHEREAS, the Town Board desires to assume Lead Agency status and conduct a review to determine the significance of the proposed Local Law in accordance with Article 8 of the Environmental Conservation Law of the State of New York, and the regulations promulgated thereunder at 6 NYCRR 617.

WHEREAS, a public hearing has been noticed and scheduled by the Town Board for November 22, 2016 at 7:00 pm for all persons interested in presenting oral or written comments concerning the proposed local law.

NOW, THEREFORE, BE IT RESOLVED that:

All "Whereas" clauses are hereby incorporated by reference as Section 1. though set forth in full herein.

The Town Board determines that the proposed action will require review pursuant to the State Environmental Quality Review Act (SEQRA), and the governing regulations promulgated thereunder.

The Town Board hereby declares itself as Lead Agency in Section 3. connection with the SEQRA review of this application and, in this capacity, the Town Board will determine if the proposed Local Law will have a significant adverse environmental impact.

Section 4. The Town Board hereby determines that the proposed Local Law is an Unlisted Action under SEQRA.

The Town Board directs that a Short Environmental Assessment Section 5. Form (SEAF) be prepared and reviewed.

Section 6. The Town Board directs the Town Clerk and any other officer of employee, as directed by the Supervisor, to take any action necessary to carry out the provisions of this Resolution.

Section 7. This Resolution shall take effect immediately.

Open Public Hearing

A motion was made by Supervisor Monaghan, seconded by Councilman Puccio and unanimously carried by a voice vote of those board members present to open this public hearing at 7:06 pm.

Supervisor Monaghan explained that this proposed amendment is to allow LED signs for first responders, such as ambulance, fire and police, not for commercial and retail stores.

Public Input

- George Potanovic, 597 Old Gate Hill Road
 - Questioned the notification process
 - What is the true purpose of the signs
 - Who has control of sign content
 - Concerned about distracted driving
- Supervisor Monaghan
 - o Indicated that this public hearing was set earlier in the fall and has been announced and talked about numerous times
- Kathy Leroy President, Stony Point Ambulance Corp
 - o Signs will not be flashing and there will be no commercial advertising
- Chief Brian Moore
 - o Messages will involve safety, road closures, amber alerts, evacuation routes, fire safety – health, safety and general welfare of the community
- Susan Filgueras, 87 Mott Farm Rd
 - o Fifth amendment right can we dictate what a message will be
 - Will signs be within the character of what we want the town to be
 How can we control what happens when new people come in
- George Potanovic, 597 Old Gate Hill Road
 - o Is there a sample sign that can be looked at that shows size, type and style
- Rich Perry Stony Point Ambulance Corp Sr. Advisor/Youth Corp
 - o A sign like this will get message to the youth of the town

- Councilman Basile
 - Make sure it is well planned
 - Will get message to potential volunteers
 - Should go with the look of the town
- Supervisor Monaghan
 - Fire department and ambulance corp are second and third generations of volunteers
 - Great way to get the message out
 - We can't stop progress being concerned about lawsuits
- Councilman Javenes
 - Signs should be consistent with the look of the town
- Brian Nugent, Special Counsel spoke as to the legal challenges:
 - Proposed Local Law is not a restriction on speech or anything of that nature
 - Town Board is authorizing a particular type of sign not necessarily relative to the content
 - The purpose of this law is to authorize specific types of messages which is the community welfare/emergency public notice type of messages
 - A goal of the Town Board in doing this is to make these LED signs unique in that when you see them, especially when you are driving, the messages are always going to be public notices
 - If you allow commercial entities to have these signs you defeat the purpose of the law
 - Compelling government interest to get those messages out is one of the issues that would be looked at
 - If a commercial entity should sue because these signs are authorized it can be compared to the Town saying every emergency service could have a flashing purple light on the roof and no one else can – we are putting our messages out and no one else is going to be able to do that
 - Anyone can sue the question is whether or not they would prevail
 - We can't stop anyone from going to court
 - We can move to dismiss an action and in this case we would succeed if that's the kind of claim that was brought for this local law

ACTION- CONTINUE PUBLIC HEARING

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to continue the public hearing at the December 13th Town Board meeting.

USE OF SOUND STAGE - PAL

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by those board members present to allow PAL to use the sound stage and Kirkbride Hall, surrounding grounds and the parking lot adjacent to Cornell Cooperative Extension for their Bike Safety/Touch a Truck Event on June 4, 2017 with a rain date of June 11, 2017.

BOY SCOUT CHRISTMAS TREE PERMIT

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to waive the fee and grant the permit to sell Christmas trees to Boy Scout Troop 10 at the Atonement Lutheran Church 71 Central Highway from November 25-December 23, 2016.
