- <u>Ted L'Estrange</u> Ottisville, NY spoke on behalf of Falun Gong practitioners in the Hudson Valley asking that the Town Board consider adopting a resolution condemning China's state-sanctioned harvesting organs from Falun Gong practitioners for profit.
- <u>Frank Collyer</u> Knapp Rd. spoke asking the Town Board to consider the legibility and safety associated with LED signs, asking the Board not to adopt the new proposed sign law.
- George Potanovic, 597 Old Gate Hill Rd thanked the Board for all the effort they
 went through to improve the sign law and spoke about the size and readability of
 proposed LED signs.

SUPERVISOR'S REPORT

Supervisor Monaghan spoke as follows:

• It has recently come to my attention that Town residents have been the subject of inappropriate solicitations at their homes by individuals seeking to induce a sale of the home and, in some cases, presenting false information to homeowners. This problem is not unique to the Town of Stony Point and has been occurring in other areas of New York State and beyond. In order to address this problem, I would like to introduce an amendment to Chapter 159 of the Town Code (Peddling and Soliciting) to address and prohibit this type of conduct.

I would like to ask the Town's Special Counsel to draft such an amendment and provide it to the Town Board for review.

I would also like to make a motion to set a public hearing on March 14, 2017 to consider the adoption of the proposed amendment and to allow the public an opportunity to comment on the proposed amendment. The Town will post the draft local law on the Town website when it is received from legal counsel.

<u>Proposed Local Law - Amend Town Code Chapter 159 to Expand Regulations of Peddling and Solicitation</u>

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to set a Public Hearing on March 14, 2017 to consider adoption of a proposed amendment to the Town Code-Chapter 159 to Expand Regulations of Peddling and Solicitation

- Trees for Trips Program the Town has applied for this program, which is at no cost to the Town, to plant trees along our waterways to help with erosion and beautification. Superintendent of Highways Larry Brissing has been very instrumental in this effort which also involves the boy scouts.
- April 1st the Town will be participating in the Great American Cleanup which is also being spearheaded by Superintendent Brissing.
- Recreation Department is in need of lifeguards for the 2017 season at the Town pools.

POLICE DEPARTMENT REPORT/BUSINESS

Police Dept Emergency Purchase Order #2825

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to approve Purchase Order #2825 for Ford Motor Company in the amount of \$5,736.93 to replace the motor in a 2013 Ford Utility Interceptor for the Police Department.

Update - Police Officer Retirement

Officer Lodini was retired by the New York State Retirement System effective February 16, 2017. Chief Moore asked for permission to request the police officer eligibility list from Rockland County Personnel.

Request List - Police Officer

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to authorize Chief Moore to request the eligibility list for police officer from the Rockland County Personnel Office.

CONTINUED PUBLIC HEARING -AMEND SIGN LAW

Supervisor Monaghan recapped as follows:

The Town Board had previously left the public hearing open on the adoption of the amendment to the Town Code for written comments only. The Town had referred the proposed law to the Rockland County Department of Planning, the Rockland County Highway Department, the New York State Department of Transportation and the Town Planning Board. Those referrals were sent out by the Town Clerk on 1-25-17. As of today, the Town Planning Board responded as well as the Rockland County Department of Planning and we also had a written response today from George Potanovic that I made sure the Board members were made aware of and received. The Rockland County Department of

Planning had recommended that a list be generated listing the emergency service organizations that would be subject to the amendment. I have that list and a little later I'm going to recommend that the Board adopt that recommendation. As to the Rockland County Department of Planning's recommendation to have the law reviewed by the Rockland County Department of Highways and the New York State Department of Transportation, the Local Law was forwarded to both entities over thirty days ago and no comments have been received by either agency. The Town Board has reviewed and considered all oral and written comments on the proposed amendment to the local law.

Close Public Hearing

At 7:20 pm a motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to close the public hearing.

Adopt Negative Declaration

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to adopt a negative declaration amending the zoning ordinance of the Town of Stony Point regarding LED signs at emergency service organizations sites.

Adopt Local Law No. 1 of 2017 – To Amend the Code of the Town of Stony Point by Amending Chapter 215, Article IX to Allow the use of LED signs by Emergency Service Organizations and First Responders

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to adopt Local Law No. 1 of 2017 to amend the Code of the Town of Stony Point by amending Chapter 215, Article IX to allow the use of LED signs by emergency service organizations and first responders.

Designate Emergency Service Organizations

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present to designate the following four sites as emergency service organization sites within the Town of Stony Point:

- Stony Point Ambulance Corp., 47 South Liberty Drive, Stony Point, NY 10980
- 3. Stony Point Fire District, 25 North Liberty Drive, Stony Point, NY 10980
- 4. Stony Point Fire District Substation, 199 Central Highway, Stony Point, NY 10980

2017 Renew Contract - High Tor Animal Shelter

A motion was made by Supervisor Monaghan, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to authorize the Supervisor to enter into a one (1) year agreement with Hi-Tor Animal Care Center, Inc. for payment of One Thousand, Eight Hundred and Thirty Seven & 50/100 dollars (\$1837.50) per quarter for the year 2017.

Mosquito Control

A motion was made by Supervisor Monaghan, seconded by Councilman Puccio and **unanimously carried** by a voice vote of those board members present to accept Rockland County Health Department's proposal for Mosquito Control at Tiorati Trails, Carlton Fields, Petersen Estates, Zachary Taylor, JF Kennedy, Rider Hill & Lowland Hill Brush Yard at a fee of \$5000.

Use of Sound Stage PAL

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present to approve the

use of the Town's Sound Stage by PAL on May 12, 2017 from 5:00PM – 9:00PM at the North Rockland High School for the 2nd annual 5K Color Run.
