

Supervisor Monaghan:



We have no objection to your signing this as part of the settlement of that litigation. We had requested one modification which was agreed to by the parties as the prior version was too broad in its language.

An electronic copy is sufficient, but I would recommend that a resolution first be adopted authorizing you to sign the Release. If you want to add it on tonight, the language of the resolution would be:

BE IT RESOLVED that the Town Supervisor is authorized to execute a General Release, as recommended by the attorney representing the Town, in the Matter of Elkhorn Properties, LLC v. County of Rockland and Town of Stony Point, Rockland County Supreme Court, Index No. 34627/2020.


