PUBLIC INPUT

<u>Sgt. Jay Wood</u>-PBA President spoke urging the Board not to cut funding or positions at the Police Department in the interest of safety and to be able to continue to give the people of Stony Point the quality of police services they have grown to expect for the last 30 years.

Ralph Heavner-Oak Ct. spoke indicating that at some point the Board must realize that it is impossible to make any further cuts. He commended the Highway Dept for the exemplary job during recent extreme weather conditions and the Police Dept for the exemplary job responding to two recent incidents in his neighborhood.

<u>Former Chief of Police Steven Scurtie</u>, spoke recapping the history of the police department, urged the Board to use professionals such as the chief, in the budget process, pointed out several areas of concern to the residents and indicated that the tax base must be increased, stating that police & town services are a top priority to someone looking to invest in the town.

<u>Chief Brian Moore</u> spoke, recapping staffing levels for 2010, 2011 and 2012, indicating that understaffing jeopardizes the safety and security of the community. He also presented a power point presentation showing a rise in crime statistics within the town, indicating his pride in the department for a job well done in spite of understaffing. Chief Moore continued by offering his belief that the most prudent funding option would be to BAN the funding to maintain the positions needed in the department and covering the cost of retirements.

CLOSE PUBLIC HEARING

A motion was made by Councilman Finn, seconded by Councilwoman Konopko and **unanimously carried** by a voice vote of those board members present to close the public hearing on the 2012 preliminary budget at 8:29 pm.
