ZBA APPOINTMENT:

A motion was made by Supervisor Finn to appoint Michael Grall to the Zoning Board of Appeals. No second was made, therefore, the **motion failed.**

A motion was made by Councilman Javenes, seconded by Councilman Basile and **unanimously carried** by a roll call vote of all board members present to reappoint Joe Vasti to the Zoning Board of Appeals for a term of five (5) years with term ending December 2021.

PLANNING BOARD APPOINTMENT:

A motion was made by Councilman Javenes, seconded by Councilman Basile and **unanimously carried** by a roll call vote of all board members present to appoint Mike Ferguson to the Planning Board to fill the unfinished term of Gladys Callahan. His term will expire 12/2017.

EXTENSION OF CONTRACT - WEST POINT TOURS

A motion was made by Councilman Javenes, seconded by Councilman Basile and carried by a voice vote of all board members present, with Councilman Monaghan abstaining, to authorize the Supervisor to execute an agreement extending the contract with West Point Tours for senior bus transportation for one year from February 1, 2015 to February 1, 2016.

PGA MERCHANDISE SHOW:

A motion was made by Councilman Basile, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present to approve the Director of Golf's request to attend the PGA Merchandise Show with his assistant on January 19, 2015 – January 22, 2015 in Orlando Florida. The expense to the Town will not exceed \$900.00.

CREDIT CARD FEE INCREASE:

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of all board members present to increase the fee from 2.5% to 3% to cover credit card fees incurred by the Tax Receiver's office.

RENEW WORKERS COMPENSATION INSURANCE - PERMA

A motion was made by Supervisor, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present to renew the workers compensation insurance coverage for 2015 with Public Employer Risk Management Association, Inc. (PERMA) as follows:

- 2015 Non Police Employee \$269,585.10

HIGHWAY DEPT – EMERGENCY PO

Purchase Order No. #2642 for Newburgh Branch Transaxle in the amount of \$4,763.03 was approved when the board voted on all purchase orders. No further action was taken.

MAINTENANCE RENEWAL – TOWN CLOCK

A motion was made by Supervisor Finn, seconded by Councilman Javenes and unanimously carried by a voice vote of all board members present to approve renewal of the maintenance agreement with the Verdin Company for the Town Clock located in Malloy's Park in the amount of \$580 for 2015.

NORTH ROCKLAND SPORTS HALL OF FAME - SPONSORSHIP

A motion was made by Supervisor Finn, seconded by Councilmen Monaghan and Basile and **unanimously carried** by a voice vote of all board members present to authorize a \$300 donation for a plaque for the NR Sports Hall of Fame's annual induction dinner on January 24, 2015.

RECREATION SUPERVISOR

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to increase the Maintenance Facility Supervisor's salary from \$57,222 to \$67,222 effective January 1, 2015.

DENTAL INSURANCE RENEWAL

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present to approve renewal of dental coverage for town employees for 2015 with MetLife at a 7% increase from 2014 as on file in the Finance Office.

STONY POINT SEALS - MASS GATHERING PERMIT

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present to approve the request of the Stony Point Seals as follows for their annual Polar Plunge on Sunday, February 1, 2015:

- · Waive the requirements for a mass gathering permit
- Approve a mass gathering permit
- Approve use of the sound stage
- Approve use of the portable restrooms at Riverfront Park
- Approve use of the parking lots at the Commuter Lot on 9W, at Town Hall, Rose Memorial Library, Clark Park and Riverfront Park.

The Seals will provide the appropriate certificate of insurance to the Town prior to their event.

COMMERCIAL INSURANCE RENEWAL

A motion was made by Supervisor Finn, seconded by Councilman Basile and **carried** by a voice vote of those board members present, with Councilman White opposed, to renew the Town's commercial insurance program with New York Mutual Insurance Reciprocal (NYMIR) as presented by the Ducey Agency for the year 2015 in the amount of \$414,393 which represents an approximate 2.7% decrease in premium from 2014.

TOWN SESQUICENTENNIAL PLANNING COMMITTEE

A motion was made by Councilman Basile, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present to approve the following members of the Town of Stony Point's 150th Anniversary Committee; Susan Filgueras, Glenn Chorba, Dylan Skriloff, Kevin Metcalf, Tom Schassler and Joe Robinson as liaison for Wayne Hose Co.

EXECUTIVE SESSION

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and unanimously carried by a voice vote of all board members present to adjourn into

executive session at 8:15 pm for a report from legal counsel. Supervisor Finn announced that no further votes would be taken. He advised that there may be a special reorganization meeting prior to the regularly scheduled town board meeting on January 13, 2015 and if this were the case proper notice would be given.
