#### **PUBLIC INPUT**

Kathy Kivlehan, Miller Dr. read the following:

## POLICE DEPARTMENT REPORT/BUSINESS

#### HELEN HAYES CLASSIC RACE

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of those board members present to waive the police overtime cost for traffic control (approximately \$2,500) for the Helen Hayes Classic Race being held in North Rockland on October 15, 2014.

#### STOP DWI

Chief Moore announced that the Town of Stony Point will receive \$1,491.22 as reimbursement for the Stony Point Police Department's efforts in the STOP DWI Campaign.

## PROPOSED HELISTOP FOR PERSONAL RESIDENCE

John Perkins, Architect briefly addressed the Board regarding the proposed Helistop and described the steps taken thus far.

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to adopt the following resolution:

# RESOLUTION REQUESTING THAT THE NEW YORK STATE COMMISSIONER OF TRANSPORTATION ADVISE IF THE PROPOSED ESTABLISHMENT OF A HELIPORT AT 8 SGT. SCHWARZ IS IN COMPLIANCE WITH SECTION 249 OF THE NEW YORK STATE GENERAL BUSINESS LAW

The Town Board of the Town of Stony Point, duly convened in regular session, does hereby resolve as follows:

WHEREAS, New York State General Business Law § 249 provides that no person shall establish or improve a privately owned heliport except by authorization of the governing board of the Town/City/Village in which such private heliport is proposed to be established or improved: and

WHEREAS, New York State General Business Law § 249 provides that the governing body of a Town/City/Village shall not authorize the establishment or improvement of a private heliport at the requested location unless in accordance with the standards prescribed by the Commissioner of Transportation of the State of New York; and

WHEREAS, the heliport proposed to be established or improved will be privately owned and t he owner(s) of the real property upon which the establishment is to take place has/have consented to such establishment; and

NOW, THEREFORE, BE IT RESOLVED THAT, the New York State Commissioner of Transportation is hereby requested to make a determination as to whether or not the establishment or improvement of such a privately owned heliport complies with the standards adopted pursuant to Section 249 of the New York State General Business Law

## **USE OF COMMUTER LOT – LIONS CLUB**

A motion was made by Councilman Javenes, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to approve the request for the use of the Commuter Parking Lot for their semi-annual yard sale on May 24, 2014 with a rain date of May 31, 2014 for the Stony Point Lions Club.

#### NRHS ACADEMY OF FINANCE INTERNSHIP

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to hire an intern from North Rockland Business Alliance with a salary of \$8.00 per hour for a six week period.

## **PENSION RE-CLASSIFICATION**

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of those board members present to reclassify one full time police officer and two part time police officers enrolled in the wrong pension plan, at a one-time cost to the town of \$14,300 and an annual increase to the town of approximately \$14,700 per year. This will all depend upon necessary legislation and subsequent approval.

## **NORTH ROCKLAND COMMUNITY 5K RUN/WALK**

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to approve a Platinum Sponsorship (\$1500) for the North Rockland Community 5K Run/Walk.

## **2014 EQUIPMENT BANS**

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of those board members present to approve various asset purchases, which will be financed through the annual ban renewal.

## AWARD BID - GOLF COURSE CHEMICALS

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to award the Golf Course Chemical Bids as per the Golf Course Superintendent's recommendations as on file in the Town Clerk's Office.

#### **VACANCY - ARCHITECTURAL REVIEW BOARD**

Supervisor Finn advised that a seat on the Architectural Review Board will come up for reappointment in April. No action was taken at this time.

# ADVERTISE FOR BIDS - MOBILE SOUND STAGE

A motion was made by Supervisor Finn, seconded by Councilman White and **unanimously carried** by a voice vote of those board members present to authorize the Town Clerk to advertise for bids for a Mobile Sound Stage.

#### **EXTEND BID OPENING DATE - RHO BUILDING BATHROOM ALTERATIONS**

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to approve extending the bid opening date for RHO Building bathroom alterations to April 1, 2014 at 10am.

## **JESSUP RIDGE DRAINAGE EASEMENTS**

The following Resolution was duly offered BY Supervisor Finn and seconded by Councilman White to wit:

#### **JESSUP RIDGE DRAINAGE EASEMENTS**

WHEREAS, the Planning Board approved a subdivision entitled "Jessup Ridge West", dated March 7, 2013, last revised February 19, 2014, and

**WHEREAS**, the subdivision map requires the dedication of a drainage easement and two municipal easements to the Town as set forth in exhibit A" annexed hereto and made a part hereof, and

**WHEREAS**, the applicant has submitted such easement documents and subdivision map to the Town;

**NOW, THEREFORE, BE IT RESOLVED,** by the Town Board of the Town of Stony Point that it hereby accepts dedication of the above easements for the Jessup Ridge West subdivision, subject to recording and the following requirements:

- Submission of a letter of credit in an amount sufficient to complete the cost of the roads and related infrastructure, currently determined to be in an amount of approximately \$289,000 or in the alternative, submission of a letter of credit in an amount currently determined to be approximately \$105,000 with the remaining approximately \$185,000 to be secured by the previously forfeited line of credit currently held by the Town; and
- 2. Review and approval of the submitted easements by the Town Engineer; and
- 3. Review and approval of all documents by Special Counsel for the Town.

The question of the adoption of the foregoing Resolution was duly put to a voice vote, which resulted as follows:
