STONY POINT TOWN BOARD MEETING - JUNE 26, 2012

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, June 26, 2012 at 7:00 pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY. Supervisor Geoffrey Finn called the meeting to order and led the group in the Pledge of Allegiance. Deputy Town Clerk, Barbara Oyer, called the following roll:

PUBLIC INPUT

<u>Lillian Wilson</u>, Fonda Dr. questioned completion of the Farley Bridge and number of benches in the new park along Route 9W.

<u>Supervisor Finn</u> advised that he had talked with Assemblywoman Calhoun regarding the completion of the bridge and would share the information once he received it. The park will contain four benches, a monument donated by the Sons of the American Revolution and a street clock which hopefully, with the help of the rotary, will be paid for by donations.

<u>Kathy Leroy</u>, Easton St. spoke regarding the Environmental Protection Agency's Sustainable Communities Building Blocks Program workshops and possibility of a town newsletter.

<u>Supervisor Finn</u> thanked Councilwoman Konopko for arranging for the two workshops.

<u>Frank Collyer</u>, Knapp Rd., spoke urging the Town Board to look into the possibility of using hybrid cars as police vehicles, look into recent legislation regarding SEQRA determinations after public hearings have been held and the lack of diving boards at the town pool.

<u>George Potanovic</u>, Old Gate Hill Rd. thanked Councilwoman Konopko for arranging the Environmental Protection Agency's Sustainable Communities Building Blocks Program workshops, spoke against the Champlain Hudson Power Express project and urged an extension of the public hearing for another sixty days.

Christine Eiffel-Dana spoke thanking Councilwoman Konopko for arranging the Environmental Protection Agency's Sustainable Communities Building Blocks Program workshops and the Painted Paw Brigade raising nearly \$10,000 for the North Rockland Rowing Club and Hi-Tor Animal Shelter. The dog that she bid on and won shows a pictorial history of North Rockland and she would like to put it on loan for display starting with the Town of Stony Point.

<u>Susan Filgueras</u>, Mott Farm Rd spoke against the Champlain Hudson Power Express project, pointing out what she believes to be many problem areas.

<u>Al Samuels</u>, Garnerville and President of Rockland Business Association spoke against the Champlain Hudson Power Express project indicating it has no direct value to this area.

VOLUNTEER FIRE/AMBULANCE HEALTH INSURANCE

A motion was made by Supervisor Finn, seconded by Councilman Javenes and unanimously carried by a voice vote of those board members present to adopt the following resolution:

RESOLUTION

WHEREAS, the Town of Stony Point is served and protected by the brave and selfless commitment and sacrifice of numerous volunteer firefighters and ambulance workers; and

WHEREAS, many of these volunteers risk their physical health, safety and well-being for those in our community in need without the benefit of adequate health insurance coverage for themselves and their families; and

WHEREAS, offering a group health insurance option may serve as an incentive in the recruitment and retention of volunteers; and

WHEREAS, New York State has previously adopted Chapter 71 of the Laws of 2010 which allows municipalities throughout New York State to extend coverage availability under the NYSHIP program to volunteer firefighters and ambulance workers provided the volunteers pay the total cost of such insurance coverage; and

WHEREAS, the Town of Stony Point desires to extend the availability of NYSHIP benefits to volunteer firefighters and ambulance workers serving fire or ambulance companies operating within the Town of Stony Point provided that, pursuant to General Municipal Law § 92-a and New York State Civil Service Law § 163, the volunteers are responsible for paying the cost of said benefit coverage and such volunteers provide proof of their status as active volunteers consistent with the provisions of General Municipal Law § 92-a;

NOW THEREFORE BE IT,

RESOLVED, that the Supervisor is hereby authorized and directed to execute any and all documents necessary to extend availability of the Town's NYSHIP benefits, pursuant to New York State General Municipal Law § 92-a to those volunteer firefighter and ambulance workers who are active members of fire and ambulance companies within the Town of Stony Point and are eligible to receive such coverage under the provisions of General Municipal Law § 92-a; and be it further

RESOLVED, that the Town Clerk is hereby authorized and directed to send a copy of this resolution to all volunteer fire and ambulance companies in the Town of Stony Point.

CAPITAL EQUIPMENT BOND RESOLUTION MODIFICTION

A motion was made by Councilman Javenes, and seconded by Councilman McDonnell to adopt the following resolution:

RESOLUTION OF THE TOWN BOARD OF THE TOWN OF STONY POINT, ROCKLAND COUNTY, NEW YORK (THE "TOWN"), AMENDING A BOND RESOLUTION DATED MAY 18, 2012, RELATING TO THE AUTHORIZING OF SERIAL BONDS OF THE TOWN TO FINANCE VARIOUS PUBLIC IMPROVEMENTS

WHEREAS, the Town Board (the "Town Board") of the Town of Stony Point (the "Town") by bond resolution duly adopted by the Town Board on May 18, 2012 (the "Original Bond Resolution"), authorized, among other things, the issuance of \$200,000 in serial bonds of the Town to finance the acquisition of two (2) plow trucks with spreaders and plows, at a total estimated maximum cost of \$200,000 (the "Original Project"); and

WHEREAS, the Board now wishes to amend the Original Bond Resolution to amend the Original Project to consist of the acquisition of (i) one (1) plow truck with spreader and plow and (ii) one (1) skid steer with a snow plow attachment, both for use by the Town's Highway Department (as so revised, the "Project"); and

WHEREAS, the Project constitutes a "Type II" action under the New York State Environmental Quality Review Act and the regulations promulgated thereunder (6 NYCRR Part 617.5(c)) (collectively, "SEQRA") and therefore no further action need be taken by the Town Board under SEQRA as a pre-condition to the adoption of this resolution.

NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF STONY POINT, ROCKLAND COUNTY, NEW YORK HEREBY RESOLVES (by the affirmative vote of not less than two-thirds of all the members of such body), AS FOLLOWS:

SECTION 1. Section 3 of the Original Bond Resolution is hereby amended in its entirety to read as follows:

The Town is hereby authorized to undertake the "SECTION 2. acquisition of (i) one (1) plow truck with spreader and plow at a maximum estimated cost of \$160,000 for use by the Town's Highway Department and (ii) one (1) skid steer with a snow plow attachment at a maximum estimated cost of \$40,000 for use by the Town's Highway Department and to issue \$200,000 principal amount of serial bonds (including, without limitation, statutory installment bonds) pursuant to the provisions of the Law to finance the estimated cost thereof. It is hereby determined that the maximum estimated cost of the aforementioned specific objects or purposes is \$200,000, said amount is hereby appropriated therefore and the plan for the financing thereof shall consist of the issuance of the \$200,000 in serial bonds of the Town authorized to be issued pursuant to this section or bond anticipation notes issued in anticipation of such bonds. It is hereby determined that the period of probable usefulness for the aforementioned specific objects or purposes is fifteen (15) years, pursuant to subdivision a.28. of Section 11.00 of the Law."

SECTION 2. Except as specifically amended herein, all the terms and provisions of the Original Bond Resolution shall remain in full force and effect.

SECTION 3. This resolution shall take effect upon adoption.

AWARD BID - SALT SHED HIGHWAY DEPARTMENT

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to award the bid for a salt shed to Free Span Structures, Inc. in the amount of \$92,185.00 contingent on the above mentioned company providing proof that they are registered with the New York State Secretary of State to do business in the State of New York, and a signed contract from the NYS Dormitory Authority with regard to the Town receiving grant monies for the project.

HIRE - POOL OPERATOR

A motion was made by Councilman White, seconded by Supervisor Finn and **unanimously carried** by a voice vote of those board members present to hire Thomas Brennan as a Pool Operator with a 2% raise over the 2011salary.

HIRE RECREATION FACILITY ATTENDANT

A motion was made by Supervisor Finn, seconded by Councilman Javenes, and **unanimously carried** by a voice vote of those board members present to hire Joseph Dibble as a Recreation Facility Attendant starting salary to be \$9.50 per hour.

AUGUST & SEPTEMBER 2012 MEETING DATES

A motion was made by Supervisor Finn, seconded by Councilman McDonnell, and **unanimously carried** by voice vote of those board members present to change the Town Board meeting schedule for August and September, 2012. The meeting schedule is as follows:

INTEL AGREEMENT - 2012

A motion was made by Supervisor Finn, seconded by Councilwoman Konopko, and **unanimously carried** by a voice vote of those board members present to approve the 2012 Intel Agreement with the County of Rockland for January 1, 2012 – June 30, 2012.

DESIGNATE DEPOSITORY

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to designate the First Niagara Bank (formerly HSBC) as an official depository for the Town of Stony Point.

OFFICIAL ZONING MAP

A motion was made by Councilwoman Konopko, seconded by Supervisor Finn, and **unanimously carried** by a voice vote of those board members present to request a copy of our town's zoning map from Rockland County Planning for the purpose of approving by resolution as our official town zoning map.

NATIONAL DEVELOPMENT COUNCIL

<u>Supervisor Finn</u> explained that there is interest in the property at the Patriot Hills Complex and introduced <u>Daniel Marsh</u>, Regional Manager from the National Development Council which specializes in community and economic development activities. Mr. Marsh gave a brief description of what his organization does.

Supervisor Finn read the following resolution:

4. The role of NDC shall be to utilize its expertise to attract and identify such good commercial tax ratables, but the determination as to whether such ratables shall be located in the Town shall vest solely with the Town Board pursuant to Town Law.

This shall take effect immediately.

ACTION

After much discussion Supervisor Finn made a motion, seconded by Councilman White and **unanimously carried** by a voice vote of those board members present to revise the resolution as follows:
