PRESENTATION OF 2015 TENTATIVE BUDGET

The 2015 Tentative Budget was presented to the Town Board by Town Clerk Joan Skinner. A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to set a budget hearing for 7:00 pm at the regular October 14th Town Board meeting to review the 2015 Tentative Budget.

ZONE CHANGE PETITION – MBC HOLDING CO., LLC.

With regard to a zone change petition submitted by MBC Holding Co., LLC for tax lot 20.02-11-28 from R-1 to LI-2, a motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to declare the Town as lead agency, classify the action as a Type 1 and direct the Town Clerk to distribute the Petition to Rockland County Planning Board, Stony Point Planning Board, the Department of Environmental Conservation and all other necessary agencies.

AWARD BID-DRAINAGE IMPROVEMENTS LAKE ROAD AREA

A motion was made by Supervisor Finn, seconded by Councilman Javenes and unanimously carried by a voice vote of all board members present to award the bid for drainage improvements at Lake Rd., Williams Rd., High Ridge Rd., Major Andre Dr. and Rosebud Dr. to Environmental Construction Inc. in the amount of \$299,569.25.

APPOINTMENT – BOARD OF ASSESSMENT REVIEW

A motion was made by Councilman Javenes, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present to reappoint Thomas Dunn to another five year term on the Board of Assessment Review. Said term will run until October of 2019.

ROCKLAND MOBILE CARE CONTRACT FOR 2015

A motion was made by Supervisor Finn, seconded by Councilman Monaghan and **unanimously carried** by a voice vote of all board members present to authorize the Supervisor to enter into an agreement with Rockland Mobile Care Inc. for paramedic services for the Town of Stony Point for 2015 at the same cost as 2014; that is \$328,153. This is contingent of review and approval of the contract by Special Counsel.

PROPOSED LOCAL LAW - SIGN LAW

A motion was made by Supervisor Finn, seconded by Councilman Basile and unanimously carried by a voice vote of all board members present to accept the following resolution:

A RESOLUTION RELATING TO THE INITIAL REVIEW UNDER THE STATE ENVIRONMENTAL QUALITY REVIEW LAW OF THE PROPOSED LOCAL LAW ENTITLED, "A LOCAL LAW AMENDING THE TOWN OF STONY POINT CODE TO PERMIT GATEWAY SIGNS"

WHEREAS, the Town of Stony Point desires to allow Gateway signs, including Electronic Gateway Signs at entrances to the Town or at entrances to areas within the Town; and

WHEREAS, the Town Zoning Code requires an amendment to allow such signs by Special Permit; and

NOW THEREFORE, BE IT RESOLVED that:

1. The above WHEREAS clauses are incorporated herein by reference.

2. Pursuant to, and in accordance with, the provisions of section 617.6 (Initial Review of Actions and Establishing Lead Agency) of the New York State Environmental Quality Review Regulations (6 NYCRR part 617) the Town Board hereby makes the following determinations and classifications with respect to the Town of Stony Point Proposed Local Law entitled, "A Local Law Amending the Town of Stony Point Code to permit Gateway Signs."

- a. The Town Board hereby determines that the action is subject to SEQR.
- b. The Town Board hereby determines that the action does not involve a Federal agency, and does not involve other agencies.
- c. The Town Board hereby makes a preliminary classification of the action as an unlisted action.
- d. The Town Board hereby determines that it is, and will be, the lead agency with respect to the adoption of, and approval of, the above-described amended Local Law.

3. A public hearing with reference to the above-described proposed Local Law shall be held on **October 28, 2014 at 7:00 P.M**. at 5 Clubhouse Lane (Rho Building) in the Town of Stony Point. The Town Clerk of the Town of Stony Point is hereby authorized to publish a notice of said public hearing in the Rockland County Times and any other official newspaper and to give notice thereof to the Rockland County Department of Planning and to other municipalities, boards and agencies entitled to notice thereof. The Town Planner is authorized to prepare an appropriate Environmental Assessment Form regarding the proposed local law.

4. A copy of the proposed Local Law and a copy of this Resolution shall be sent by the Town Clerk to the Town Planning Board, Town Zoning Board of Appeals, Building Inspector, Rockland County Department of Planning, New York State Commissioner of Environmental Conservation, and New York State Office of Parks, Recreation and Historic Preservation.

5. This Resolution shall take effect immediately.

USE OF COMMUTER LOT – STONY POINT LIONS CLUB

A motion was made by Councilman Basile, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present to grant the request from the Lions Club to use the Route 9W Commuter Lot for a garage sale on October 11th with a rain date of October 13th.

USE OF COMMUTER LOT – KNIGHTS OF PYTHIAS

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present to grant the request from Sy Samuels to use the Route 9W Commuter Lot for parking to facilitate of bus trip for the Knights of Pythias.

A motion was made by Supervisor Finn, seconded by Councilman Basile and unanimously carried by a voice vote of all board members present to surplus the following equipment for the Parks Dept and to sell it at auction:

ASSESSMENT OF EXPENSES – WATERFRONT AREA

A motion was made by Supervisor Finn, seconded by Councilman Javenes and **unanimously carried** by a voice vote of all board members present to adopt the following resolution:

RESOLUTION ORDERING ASSESSMENT OF EXPENSES AGAINST LAND PURSUANT TO CHAPTER 78 OF THE TOWN CODE OF THE TOWN OF STONY POINT

WHEREAS, the Town Board, after compliance with notification requirements of the Town Code and after a public hearing commenced on May 13, 2014 and continued on May 27, 2014, June 10, 2014, June 17, 2014 and June 24, 2014, passed a Resolution, authorizing Town officials to take any and all necessary steps to repair, remove an otherwise secure ("the services") certain structures on parcels identified in Exhibit "A" annexed to this Resolution; and

WHEREAS, the Town caused such services to be performed consistent with the findings and recommendations of the Town's Building Inspector and in doing so performed the work and incurred the expenses set forth in Exhibit "A" for property located at **53-55 Beach Road in the Town of Stony Point** as specifically set forth in Exhibit "A"; and

WHEREAS, Chapter 78 of the Town Code of the Town of Stony Point provides that All expenses incurred by the Town in connection with the proceedings to repair and secure or demolish and remove an unsafe building and/or abate the public nuisance, including the cost of actually removing such building and legal expenses, shall be assessed against the land on which such building is located and further provides that the expense so assessed shall constitute a lien and charge on the real property against which it is levied until paid or otherwise satisfied or discharged and further provides that such assessment shall be collected in the same manner and at the same time as other town charges, and that the same shall be placed on the tax assessment roll and levied against the property

NOW THEREFORE, BE IT RESOLVED as follows:

- 1. The above WHEREAS clauses are incorporated herein by reference.
- 2. The Town Board of the Town of Stony Point, after due deliberation, hereby:
 - a. Determines that the costs and expenses set forth in Exhibit "A" shall constitute a lien and charge on the real properties identified in Exhibit "A."
 - b. Authorizes the Town Assessor, Building Inspector, Finance Director, Town Clerk and any other Town Official whose assistance is required to carry out the provisions of this Resolution, to cause the costs and expenses set forth in Exhibit "A" to be assessed against the lands identified in Exhibit "A" and to collect such assessment in the same manner as other Town charges and, if not satisfied, to place same on the tax assessment roll and levy same against the subject parcels.
- 3. This Resolution shall take effect immediately.

<u>Councilman Basile</u> thanked the Highway Department and the Parks Department for the progress made cleaning up the parking lot area at the Little League Field.

EXECUTIVE SESSION

A motion was made by Supervisor Finn, seconded by Councilman Basile and **unanimously carried** by a voice vote of all board members present to adjourn into executive session at 8:08 pm to discuss personnel matters. Supervisor Finn announced that no votes would be taken.

ADJOURN The September 23, 2014 Stony Point Town Board meeting adjourned at 8:40 pm. No further votes were taken.
