Understanding Your Tax Bill

We know you probably don't look forward to receiving your tax bill, but this year Stony Point homeowners saw a 9% decrease in their town taxes from 2022! In fact, Stony Point was the only town in Rockland to see a decrease in their property taxes for 2023. To ensure you understand each charge on the bill we have provided detailed information below keyed to the sample bill above.

1 County Tax: This tax is levied by Rockland County and based on the assessed value of your property. It covers a wide variety of services including county government salaries, infrastructure projects such as highway and bridge improvements, equipment purchase and upkeep, funding for nonprofit agencies, support for seniors for property tax reductions, purchasing parkland properties, and this year, college tuition assistance for volunteer firefighters and emergency responders, among other things. We include the tax on your town bill as a courtesy to the County and then pay the County after receiving the taxes from the residents of Stony Point. 2 Town Tax: The tax levied by the Town of Stony Point is based on the assessed value of your property. Homeowners saw a 9% decrease in their town tax from 2022.

3 Ambulance District: This tax supports the local Stony Point Ambulance Corps, as well as the contract with Rockland Paramedics for Advanced Life Support. This tax is based on the assessed value of your property.

• Fire 1: The tax levied by Wayne Hose Fire Co. for operation, equipment, and maintenance. It is based on the assessed value of your property.

5 Lighting: The tax levied by the Town for payment to Orange and Rockland for street lighting.

6 Sewer: This charge is for the operation and maintenance of the Waste Water Treatment Plant in Stony Point.

Solid Waste Disposal Charge (1): This charge, levied by Rockland Green (formerly County Solid Waste Management Authority), is for capital or debt service costs for the Solid Waste Authority's facilities and general administrative costs. A portion of this charge is also for the yard waste program for composting of leaves, grass and brush collected in the County.

Solid Waste Disposal Charge (2): This charge, levied by Rockland Green, is for the operation and maintenance costs for the Materials Recovery Facility which processes all of the commingled containers and paper collected from residential properties throughout the County.

(9) Transfer Station: This charge, levied by Rockland Green, is for the operation and maintenance costs for the transfer station which is available to receive municipal solid waste from all residential properties in Rockland County. It is imposed on a per dwelling unit basis and is \$23.63 for 2023.

() Animal Management: Rockland Green has taken over the management of Hi-Tor Animal Shelter. This charge is for Animal Management and the running of the facility. The per dwelling charge for 2023 is \$19.23.

Note: Paying your tax bill in one lump sum is less expensive as it eliminates the fees imposed for partial payments.

Tips for Handling Refuse

We get a lot of guestions about how to dispose of bulk items and yard debris and what items are acceptable to dump. To help clarify, here's a quick rundown:

Grass Clippings Drop off

Due to changes in regulations, the Highway Department is no longer able to pick up grass clippings. Bring your grass clippings to the Highway Department in biodegradable bags, which are available for no charge onsite. We cannot accept any grass clippings in plastic schedule a pickup appointment. Pickbags. An annual permit is not required.

Bulk Items Drop off

An annual drop off permit (\$20, cash or check only) purchased at the Town Clerk's Office, allows residents to bring appliances,

furniture, mattresses, and other metal items to the Highway Department. You can also dispose of tires, for a fee of \$4 per tire. You may also drop off brush and bagged leaves for which an annual permit is not required. Drop off hours are Monday -Friday, 7am-3:30pm. Saturdays 9am-1pm.

Bulk Items Pickup

You can schedule a pick up of bulk items that are metal-such as appliances, bicycles, etc.-as well as bagged leaves and brush, cut and bundled in lengths no longer than eight feet. Contact the Highway Department to ups are usually on Fridays and items

should be left on the curb before 7 am. Call (845) 786-2300 or email highway@townofstonypoint.org. Be sure to include your name, address, phone number, and items to be picked up.

Hazardous & Construction Waste

Paint, chemicals, hazardous materials, household garbage, construction materials & debris, and tree stumps are not accepted. Call your garbage carter or contractor to make arrangements. or visit the Rockland Green website for further instuctions.



Stony Point Improves Financial Position

Stony Point has greatly improved its financial position over the past several years, which is welcome news for resident taxpayers.

he financial strength of the Town is reflected in the current year's budget, which reduces Town taxes by 9% AND provides for \$375,000 in road resurfacing, \$750,000 in capital equipment purchases, and \$200,000 in retirement obligations. While double digit increases in medical and property and casualty insurances had a negative impact on the 2023 budget, the Town Board worked hard to achieve this historic tax reduction while still providing for necessary expenditures. Key indicators on the financial strength of Stony Point include:

- Reduction in outstanding debt by 55%, or \$12 million from 2015-2022.*
- Increase in the Town's Fund Balance by 63.2%, or \$3.4 million from 2016-2022. The Town's total Fund Balance represents the accumulated surplus (savings) of \$8.8 Million.*
- From 2016-2022 the Town spent \$5.6 million on Capital Improvements while continuing to decrease the Town's outstanding debt.
- The Town was the beneficiary of \$530,000 in grants from the County and State since 2016 which includes:
 - > \$55,000 for a new senior bus > \$56,000 police vehicle and school radar signs
 - > \$50,000 for sidewalk repairs > \$100,000 for new playground equipment
 - > \$250,000 for the renovation of Town Hall
 - > \$75,000 for the construction of new dog park

Most importantly the Board's adopted budget for 2023 reflects a **9% REDUCTION** in Town property taxes for Stony Point homeowners. To find out more details go to to https://www.townofstonypoint.org/ town-budget-info for a copy of this years budget.

\$56,000 Grant Funds New Vehicle and School Safety

•he big news from the Police Department is the \$56,000 in grant funding we recently received! The grant, secured in cooperation with our former NYS Senator James **Skoufis**, enabled the department to purchase a new police vehicle and two new radar speed signs for our school zones. One sign was installed by Farley Elementary School (coming eastbound on Route 210), and the second is located on southbound Jay Street by Stony Point Elementary School. We're happy to be able to provide this additional speed protection near our schools in order to keep children and their families safe.

The department is also in the process of adding a new officer to our ranks to replace **Mike Heath**, who is now the Stony Point School Resource Officer. This is a great move for Mike and our whole community, and we're proud to watch him thrive in his new role. We are looking to hire a Spanish-speaking officer and the hire will come at no additional cost to the county because Mike's position is funded by the school district.

As always, we are focused on the safety of all Stony Point residents and are here to serve you!

Meet Mike Heath, Our New SRO

e are thrilled to welcome Mike Heath to our school community! Mike began serving as School Resource Officer (SRO) for both Stony Point Elementary School and Farley Elementary School in November 2022. It's been a natural fit for Mike, who grew up in Haverstraw, graduated from North Rockland High School, and currently lives in Stony Point. A 16-year veteran police officer, he spent the last 12 years as a member of the Stony Point Police Department and says he jumped at the chance to be SRO.

"My youngest child attends Stony Point Elementary and my oldest is at Farley, so I already knew so many of the students, parents, and teachers—some of whom I went to school with myself," says Mike, who has also worked with the North Rockland Youth Academy for years, and has extensive martial arts training. A typical day finds Mike making sure students arrive and depart without any issues, walking the halls to enforce safety, assisting with any security concerns that arise, and frequently giving and getting high-fives from the kids–"Especially the younger ones, who see my uniform and think I'm like a superhero," he jokes.

The construction of the courts are being completed with grant monies received from Rockland County as part of the American Rescue Plan Act.

A Little Town History: Have you visited Town Hall lately?

The current Town Hall at 74 East Main Street was constructed in approximately 1906 as the residence and office of Dr. Sengstacken, a local physician. The building, which served as a high school and elementary school during the 1950's to early 60's, is Victorian style similar to others on the street. It still features a portion of the original porch and some of the unique details from the early 1900's, including the 2nd floor balcony.

The town purchased it from the School District in 1966. It survived a fire in the 1970's and was in a constant state of disrepair for many years. However, thanks to a \$250,000 grant from the late NYS Senator William Larkin, the build-ing underwent major renovations to preserve and upgrade it inside and out. The building received a new HVAC system, new roof and insulation, as well as a paint job and new windows, helping to reduce the overall heating and cooling bills each year. We welcome residents to stop by and come inside to see the beautiful structure!

"This building is a joy to work in. It is not only historic, but also unique. You just don't see town halls like this anymore—it has a great hometown feel reflective of Stony Point's character," states Supervisor Jim Monaghan.
