Dear Honorable Board Members:

I respectfully request that the board approve sending two court clerks to the fall conference being held in Niagara Falls, NY.

The Court Clerks Conference is being held in Niagara Falls this year, making carpooling to the conference the most economical mode of transportation with costs for driving estimated at \$550 round trip including tolls. The dates for the conference are September 30, 2024, through October 3, 2024. The hotel rate is \$907 each for the duration of the conference and includes all meals. The total cost of sending both clerks is estimated to be \$2400.

The knowledge gained at these conferences continues to benefit the town in revenue, by streamlining and updating antiquated practices. The NYS Office of Court Administration, along with the NYS Unified Court System, has been granting a great deal of money for equipment, technology, and construction for the courts, and thus, expects the personnel utilizing that equipment and technology to have the education necessary to use the items to their fullest potential.
