NOTICE TO BIDDERS**

PLEASE TAKE NOTICE that sealed proposals will be received by the Town Clerk of the Town of Stony Point at 74 East Main Street, Stony Point, New York, for:

Town of Stony Point WWTP Aeration Project

Receipt of Bids: Separate sealed bids on forms prepared by the Engineer will **ONLY** be received **electronically (PDF)** by the **Town Clerk at email address mcarey@townofstonypoint.org** no earlier than **9:00 a.m. on May 19, 2020** and no later than **9:15 a.m. on May 19, 2020** for the **Town of Stony Point WWTP Aeration Project** in accordance with Drawings, Specifications, and other Contract Documents prepared by Pitingaro & Doetsch Consulting Engineers P.C.

Opening of bids will be live streamed via video conference at 9:20 a.m. on May 19, 2020 by the Town Clerk and will be publicly posted. A link to the opening of bids will be provided at a later date.

The project consists of the following:

- Construct a blower slab foundation and blower slab.
- Install Town owned blowers and appurtenances.
- Pump the liquid contents of each aeration basin to the headworks.
- Pump sludge holding tanks and digester liquid contents to neighboring tank.
- Cleanout all grit and debris from the aeration basins and sludge holding tanks. Take grit and debris offsite to a licensed facility.
- Demolish walkway planks, existing aeration equipment, and install temporary aeration piping in aeration basins.
- Furnish and install a piping system to the aeration basins, sludge holding tanks and sludge digester.
- Demolish existing aeration equipment in the holding tanks and digester tank.
- Install Town owned aeration equipment in the aeration basis, sludge holding tanks and sludge digester.
- Install Town owned control system including, but not limited to, two (2) dissolved oxygen sensors, an aeration controller, a blower control, and all associated wire and conduit.
- Furnish and install a pavilion type structure over the blowers.
- Furnish and install wire and conduit from the existing MCC to each blower.
- Furnish and install a fused, electrical disconnect for each blower.
- Furnish and install a pressure transducer and an actuated butterfly valve, and all associated wire and conduit.
- Furnish and install a 240 volt sub-panel on the proposed blower pad including wire and conduit from the Administration Building.

Pre-Bid Meeting will be held at 11:00 a.m. on May 5, 2020 at the Town of Stony Point Wastewater Treatment Plant, 24 North Street, Stony Point, NY 10980.

Each bid shall be accompanied by an acceptable form of Bid Guarantee in an amount equal to at least 5% of the amount of the Bid, payable to the Town of Stony Point as a guarantee that if the Bid is accepted, the Bidder will execute the Contract and file acceptable Performance and Payment Bonds within ten (10) days after the award of the Contract.

OWNERS RIGHTS RESERVED

The Town of Stony Point hereinafter called the Owner, reserves the right to reject any or all Bids and to waive any formality or technicality in any Bid in the interest of the Owner.

STATEMENT OF NON-COLLUSION

Bidders are required to execute a non-collusion bidding certificate pursuant to Section 103d of the General Municipal Law of the State of New York.

Attention of bidders is particularly called to the requirements relating to conditions of employment to be observed and minimum wage rates to be paid under the contract, Segregated Facilities, Section 109, and Executive Order 11246. Bidders are also required to comply with the provisions of Sections 291-299 of the Executive Law of the State of New York and all other applicable laws and regulations.

The Town of Stony Point hereby notifies all bidders that it will affirmatively insure that in regard to any Contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, sex or national origin in consideration for an award.
