Upon reading the Petition of MARGARET DWYER and WILLIAM DWYER, verified on the 6th day of May, 2020, and the exhibits annexed thereto, and the memorandum of law in support of order to show cause, all filed with this Court on May 6, 2020, upon the order to show cause entered with this Court on May 18, 2020, upon the affirmation in response to order to show cause filed by respondent on May 27, 2020, and upon the hearing that took place upon those papers on May 28, 2020 before the Hon. Robert M. Berliner, J.S.C., and it appearing that the 543 objector-signatories to the referendum petition annexed as Ex. B to the Petition cannot reasonably be individually named and personally served in this special proceeding; it is hereby,

ORDERED that notice of this special proceeding be served upon the 543 objector-signatories by publication in accordance with the requirements of N.Y. C.P.L.R. 403 by setting forth a copy of the

verified petition filed with this Court on May 6, 2020 bearing the legend "Special Proceeding Challenging Referendum Petition" and a brief description of the relief sought herein, and by providing the objector-signatories opportunity to request intervention in this special proceeding and file opposition papers to the order to show cause no later than the 14th day of July, 2020, and that said publication shall be made in the English language in one newspaper, namely, Rockland County Times, published at Nanuet, New York, once, which newspaper is most likely to give notice to the objector-signatories; and it is further,

ORDERED, that counsel for Respondent the Town of Stony Point cooperate with counsel for Petitioners in publishing the verified petition and information detailed above on Respondent's website, located at <https://www.townofstonypoint.org/>, in a prominent place on such website most likely to give notice to the objector-signatories and that such notice shall remain on the website for twenty (20) consecutive days;

ORDERED, that the publication required by this order shall be made within twenty (20) days of the entry of the within order.

The petition of Margaret Dwyer and William Dwyer respectfully alleges:

1. The Town of Stony Point, New York (the "Town") is a town in the County of Rockland duly organized and existing under and by virtue of the Laws of the State of New York.
2. The petitioners, at all of the times hereinafter mentioned were and now are electors of the Town duly qualified to vote upon a proposition to raise and expend money.
3. The petitioners reside at and are the owners of the property known as 2 Penny Lane, Tomkins Cove, New York, 10986.
4. On the 25th day of February 2020, the Town Board duly adopted Resolution No. 7 of 2020, a copy of which is annexed hereto as Exhibit "A" and made a part hereof.
5. On the 23rd day of March 2020, a petition was filed with the Town Clerk, protesting against the aforesaid Resolution and requesting that the same be submitted to the qualified electors of said Town for their approval or disapproval. A copy of said petition is annexed hereto as Exhibit "B" and made a part hereof.
6. Due to Executive Order No. 202 issued by Governor Cuomo declaring a State disaster emergency following the global COVID-19 pandemic, and Executive Order Nos. 202.8 and 202.14 that followed, the specific time limit for the filing of a written objection thereto to the Town Clerk (and this verified petition with Supreme Court, Rockland County) has been extended to May 7, 2020. A copy of the timely

written objection filed with the Town Clerk on the 6th day of May 2020 is annexed hereto as Exhibit "C" and made a part hereof.

7. The aforesaid petition is insufficient, void and not in accordance with the provisions of the Town Law of the State of New York and the Election Law of the State of New York in that:

(a) There was not appended at the bottom of each sheet of the petition a signed statement of witness or, in lieu of a statement of witness, a statement signed by a notary public or commissioner of deeds, including the specific number of the signatures that are subscribed to such petition sheet, in accordance with Section 6-132(2) and (3) of the Election Law of the State of New York and Article 7, Section 91 of the Town Law of the State of New York. In accordance with Section 6-134(11) of the Election Law of the State of New York, the number of signatures on each petition sheet is deemed to contain the number of signatures indicated on the witness statement, and the signatures in excess of the number so indicated shall be deemed not to have been filed. Accordingly, as the petition does not indicate any number of signatures on any petition sheet, none of the signatures can be deemed to have been filed; and,

(b) The essential part of the authentication of each petitioner's affirmation stating that his/her present place of residence is truly stated opposite his/her signature is missing on each petition sheet, as required by Section 6-140(1)(a) of the Election Law of the State of New York and Article 7, Section 91 of the Town Law of the State of New York.

8. No previous application for the relief sought herein has been made to any court or judge.


