3 CHAIRMAN GUBITOSA: Next item is Town of
4 Stony Point Patriot Hills. This is a lot
5 line change located on the north side of
6 Willow Grove Road and West side of Knapp
7 Road.

8 MR. STACH: Good afternoon, Board 9 Members, Chairman Gubitosa. Tonight I'm 10 here on behalf of actually the Town of Stony 11 Point because the Town wants to realign some 12 of the property boundaries and lot lines in 13 here in the vicinity of Patriot Hills.
