CHAIRMAN GUBITOSA: What we'll do first is start our meeting. We got the first item on the agenda. It's a public hearing for Nine Holt. And this is just a site plan located on the south side of Holt Drive.

Dave, this is you, right?

MR. ZIGLER: Yes. You ready?

CHAIRMAN GUBITOSA: Yeah. Just give us a quick update, and then we'll open the public hearing. I think, I know you want to continue it. So we'll just go through that.

MR. ZIGLER: Right. So at the last continuation of the public hearing, the applicant, James Boyle, went to the ARB with his architect, and they reviewed everything. We had to make one change on our plans. We put lights over the doors that face Holt Drive. So the plans are basically the same, and it's only those additional lights.

And what we have is a 28,000 square foot building with commercial in the front and warehousing in the back. And we have 44 parking spaces.

2 We received additional comments from 3 John O'Rourke. There's about four or five 4 comments on the plans, which there was 5 nothing significant. He just wanted some 6 more detail. He helped me out with that. 7 And then there was, I would say somewhere 8 between seven and ten comments on the SWPPP, 9 which is more details that he wanted, and 10 sites of where the specifications come from. 11 So we're pretty well near finished. 12 We did get a County planning memo back 13 in -- about four months ago. And we adhere 14 to everything, except one item where the 15 County interprets the code different than the 16 Town and different than the Building 17 Inspector. And I say that because this 18 building is sort of a mirror image of the one 19 which is to the east, and we're following the 2.0 same code. So we would ask the Planning 21 Board to override that. I believe it's Item Number Five on the County. 2.2 23 And that's it. If the Board has any 24 questions, we're glad to answer them. 25 CHAIRMAN GUBITOSA: All right. I quess
