SUPERVISOR'S REPORT

- <u>Veteran Tribute Banners</u> Supervisor Monaghan reported as follows:
 - I have been working with a committee, including our Town Clerk Joan Skinner, summer intern Jake Cataldo, Recreation Director Karenanne Nigro and Jared Stalter Maintenance Supervisor, with the support of the Town Board, to honor our local military members and veterans with Tribute Banners that we will display on our light poles along the Liberty Drive Corridor and Main Street. We will be offering families the opportunity, on a first come first serve basis, to have a picture of a service member's photo displayed on a banner with family name or local business name. We plan on having these banners up before this Veteran's Day. The cost to sponsor the banners will be \$150.00 to pay for the banner and hardware.

Outstanding Life Saving Achievement

On behalf of the Stony Point Town Board we are very grateful to have such a dedicated staff at our Town Pool. I would like to commend our staff, led by our Recreation Department Director Karenanne Nigro, along with our life guards, our pool operators, staff members Debi Worchansk and Joan Duboyce – this team does an excellent job. And our Buildings and Grounds Department, led by Jared Stalter. Jared along with Chicky Bruntfield makes sure the pool is up to code and in tip top shape.

Tonight we will be presenting awards to three of our life guards for Outstanding Lifesaving Achievement:

- The first award is presented to Nicole Strianese who saw two brothers that could not swim go into the deep end of the pool. Nicole blew her whistle to signal an emergency and dove into the pool to rescue the struggling boys. Our pool operator, Erin Madden, also dove into the pool to assist in the rescue. This is not the first time that Erin has made a save at our pool. Last summer she also saved a child from drowning.
- On a separate occasion Kali Javenes observed a child struggling, also in our deep end. Kali asked if the child could swim and she made a motion that she could not swim and went under. Kali's training kicked in and she immediately dove into the pool to save the drowning child.

<u>Supervisor Monaghan</u> called the three girls to the front of the room and presented them each with Outstanding Lifesaving Achievement awards. Councilman Javenes presented the award to his daughter, Kali. All members of the Town Board congratulated the girls for their great life saving work.

ENACTMENT OF NEW ZONING PROVISIONS FOR THE SITING OF SOLAR ENERGY FACILITIES IN THE TOWN OF STONY POINT

The Town Board for the Town of Stony Point is considering enacting a new provision of the Town Zoning Code concerning the siting of Solar Energy Facilities in the Town of Stony Point which would add new provisions to the Town Code to allow the siting of Solar Energy Facilities in the Town, subject to the provisions of such Code language.

The full text of the proposed Local Law will be on file in the Town Clerk's Office, 74 East Main Street, Stony Point, New York, no later than July 26, 2017, and may be obtained by any interested parties from 8:00 AM to 4:30 PM, Monday through Friday.

Open Public Hearing

At 7:35 pm a motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present Councilman Puccio appearing via video-conference from Carretera B'avaro) to open this public hearing.

Public Input

<u>Deirdra O'Connor</u>, 3 Cross Creek Lane stated that this type of energy is very positive for our community but she is concerned about the separation of church and state and wants to make certain that religious areas are not used for public profit or public gain.

<u>Susan Filgueras</u> 87 Mott Farm Road asked what O&R's involvement would be and how they would work with the solar company.

<u>Councilman Basile</u> asked our Assessor, <u>William Beckman</u> to give the Town Board a report on what this would mean to the Town of Stony Point.

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to continue this public hearing at the September 12th meeting.

Change in Abstracts

A motion was made by Supervisor Monaghan, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to correct Abstract #13 Sewer Fund – Voucher #22, has been voided out for \$1111.00, changing the balance on the sewer fund from \$17309.74 to \$16198.74. And correct Abstract #14, Voucher #794 GM Financial; had a late fee of \$12.88 attached, the fee has been waived changing the dollar amount to \$257.67; this changing the total of the General Fund to \$228,577.38 from \$228,590.26.

Nominate Police Candidate

Councilman Javenes stated that Chief Moore is recommending that James Monaghan III be nominated to fill the vacant police officer position. This nomination will allow Rockland County Personnel to continue the testing of the candidate.

A motion was made by Councilman Javenes, seconded by Councilman Basile and carried by a voice vote of those members present, (Councilman Puccio appearing via video-conference from Carretera B'avaro). Supervisor Monaghan abstained from the vote.

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to surplus the following two vehicles as requested by Jared Stalter, Maintenance Supervisor:

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to approve payment of 70 hours of vacation time amounting to \$2,191.70 for Ruthann Melia as of her retirement on 7/31/2017 as reported by the Principal Account Clerk.

Playground Program Refund

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to approve a refund of \$50.00 for Aiden Shovlin for one week of Playground Program due to a family medical emergency.

Day Camp Refund

A motion was made by Supervisor Monaghan, seconded by Councilman White and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to approve a refund of \$150.00 for five year old Mason Pommerencke of 7 Stubbe Dr. as he is attending the Playground Program.

Designate Lifeguard to Pool Operator

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to approve promoting Nicole Strainese from Lifeguard to pool operator at a salary of \$15.00.

Renew Lease – Postage Machine

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to approve a new lease with Mail Finance (Neopost) commencing on August 16, 2017 for a term of 60 months at \$130.00 per quarter.

<u>Driveway Repair - 15 Dunderberg Rd.</u>

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present (Councilman Puccio appearing via video-conference from Carretera B'avaro) to approve repairs to the driveway at 15 Dunderberg Rd. in the amount of \$585. This was due to repairs of some drainage issues at this location when the homeowner allowed the Town the use of their driveway to remove material from the drainage headwall with the assurance that the Town would repair any damage and seal the driveway.

Close Meeting

<u>Supervisor Monaghan</u> closed the August 8, 2017 Stony Point Town Board meeting in loving memory of the Honorable Louis R. Vicari, who passed away on July 30, 2017. Lou was Town Justice for 24 years and served as a Town Councilman for four years. With these years serving the Town, together with over 40 years as a private practice attorney, Lou served his Town well. He will always be remembered as a true gentleman who spoke with a voice of reason.
