CORRESPONDENCE

Supervisor Monaghan read a recent letter from Cornell Cooperative Extension:

Dear Supervisor Monaghan: I'm writing to thank you for so quickly responding to our plumbing problem. We called the Town last week to make you aware of a plumbing problem we discovered in the basement. The stainless steel waste pipe had developed holes on top of the pipe in two areas. Of course we were concerned about sewer gas and the health and safety of our staff and visitors.

On Monday two Town employees, Kurt Wicks and Tom Cass Jr., from your Parks & Rec Department showed up to assess the situation. They suggested they could readily replace segments of the pipe. They arrived Wednesday morning to begin work and assured me they'd be finished in the morning or at the latest by the end of the day. The kitchen and bathrooms would be unavailable during that time so I was anxious that the work go quickly. As promised, they completed the job by noon even though they had to cut through the pipe in several places as well as the block wall. After repairing the pipe, they thoroughly cleaned the mess made from chipped concrete block.

Thank you for sending Mr. Wicks and Mr. Cass who were courteous and efficient. The Town is fortunate to have such dedicated and professional employees.

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and carried by a voice, with Councilman White abstaining, to set the salary for newly appointed Deputy Town Clerk, Holli Finn at \$54,000, effective December 1st, 2017.

Re-Appoint – Member - Zoning Board of Appeals

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to re-appoint Wellington T. Casscles to another five-year term on the Zoning Board of Appeals, term to expire on 12-31-2022.

Re-Appoint – Member - Zoning Board of Appeals

A motion was made by Supervisor Monaghan, seconded by Councilman Javenes and **unanimously carried** by a voice vote of those board members present to re-appoint Tom Wright to another five-year term on the Zoning Board of Appeals, term to expire on 12-31-2022.
