STONY POINT TOWN BOARD MEETING - February 25, 2020

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, February 25, 2020 at 7:00pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY. Supervisor Monaghan called the meeting to order and led the group in the Pledge of Allegiance.

<u>Supervisor Monaghan</u> stated that he would be opening and closing the meeting in memory of Doris Joyce. Doris was a longtime member of the Stony Point Planning Board. She was a dedicated volunteer for many organizations including Helen Hayes Hospital, the North Rockland Food Pantry and a vocal advocate for the Stony Point Seniors.

PRESENTATION - ROCKLAND RECOVERY HOMES

<u>Supervisor Monaghan</u> welcomed board members of Rockland Recovery Homes. The organization attended the meeting to speak to the public and town board in reference to a group home at 328 Willow Grove Road. The property is located in the Town of Haverstraw but in close proximity to the Town of Stony Point.

<u>Supervisor Monaghan</u> introduced Steve Clemente, Board Member of Rockland Recovery Homes.

Mr. Clemente explained the goal of Rockland Recovery Homes and his personal experience dealing with the death of his son due to an opiate overdose. The intention of the organization is to work with people with addiction and provide a safe environment free of drugs and alcohol where the clients can work on recovery after leaving inpatient and outpatient programs available.

<u>Brion Hayman</u>, Board Member of Rockland Recovery Homes, explained that Rockland Recovery Homes is the last stage for recovering addicts before re-entering into society. Offering this kind of program is crucial for success.

<u>Maureen Hyatt</u>, Board Member of Rockland Recovery Homes, explained her personal experience with a family member and the expense related to having this kind of program. Rockland Recovery Homes is meant to offer the necessary atmosphere for recovery success with out the burden of expense on the family. She went on to explain the screening process and precautions taken to prevent client setbacks.

<u>Supervisor Monaghan</u> asked Chief Moore for a computation of opiate related police responses in Stony Point.

Chief Moore gave a total for the last three years:

2017 – 2 deaths and 8 saves using Narcan

2018 – 3 deaths and 5 saves using Narcan

2019 – 8 deaths and 13 saves using Narcan

2020 - to date already 3 saves and 2 possible deaths still under investigation.

<u>Supervisor Monaghan</u> opened the floor to questions from the audience.

Town Board Minutes February 25, 2020 George Harris, 327 Willow Grove Rd, questioned the safety of the location and the cost of rehabbing the building.

Steve Clemente stated that the location would be as safe as other homes in the area.

<u>Supervisor Monaghan</u> questioned the gender and number of residents.

<u>Steve Clemente</u> responded that the home would not be co-ed, however, at this time unsure of gender.

<u>Brion Hayman</u> stated there are five bedrooms in the current home and would allow to house 8 residents and a home manager.

Councilman Puccio questioned curfew.

<u>Councilman Basile</u> commended the Clemente Family and Rockland Recovery homes for all they have done to help families who are struggling with addiction. He stated his full support for the project, referencing his work with Senator Larkin to provide access to the state-owned home for the organization. He indicated that late-stage transitional facilities like the one proposed are vital to ensuring those in recovery don't relapse. He voiced confidence that any safety concerns on Willow Grove road could be effectively mitigated."

Chris Reegan, Hidden Hills Dr., questioned security control.

Brion Hayman, reiterated the screening process and assurance that no drugs are permitted.

<u>Supervisor Monaghan</u> stated over the years Stony Point membership in the Golf Course has dwindled.

Gregg Julian, Ridge Top Dr., criticized the Town Board actions relating to recent projects.

George Harris, 327 Willow Grove Rd., spoke on:

- Condition of the Letchworth Buildings and need for maintenance.
- Need for improvements to Willow Grove Rd.
- Expectations of residents to have a presentation from potential Letchworth property buyer with models of what is proposed.

Councilman Basile stated the great cost of rehabbing buildings.

<u>Kevin Maher</u>, Central Highway, expressed concerns of the EAF relating to the sale of the Letchworth property.

<u>Steven Leonardo</u>, 137 W. Main St., shared a letter to the Planning Board with comments on the Eagle Bay project.

RESOLUTION OF THE TOWN BOARD FOR THE TOWN OF STONY POINT, NEW YORK ADOPTING A NEGATIVE DECLARATION CONCERNING THE PATRIOT HILLS TOWN OF STONY POINT LAND TRANSFER OF APPROXIMATELY 270 ACRES

WHEREAS, the Town of Stony Point ("Town") is the owner of certain parcels of land identified on the Tax Maps as Parcels 19.02-1-1.1; 14.04-1-26; and 19.02-1-3 ("Town Property"); and

WHEREAS, the Town Board for the Town of Stony Point ("Town Board") seeks to transfer said Town Property to Patriot Hills Park, LLC ("Patriot Hills"); and

WHEREAS, no physical changes subject to environmental review are proposed as a result of this action; and

WHEREAS, the Town Board is the sole agency involved in the consideration of the proposed action and thus declared itself Lead Agency pursuant to New York State Environmental Quality Review Act (SEQRA), and the governing regulations promulgated thereunder for the required environmental review of this action to determine whether the proposed Local Law will have a significant adverse environmental impact; and

WHEREAS, the Town Board had previously prepared, evaluated, and adopted the Part I and II of a Full Environmental Assessment Form (FEAF) concerning the proposed sale of the Town Property; and

WHEREAS, the Town Board has now considered the FEAF Part III, which evaluates the potential impacts of the proposed sale of the Town Property; and

NOW, THEREFORE, BE IT RESOLVED that

<u>Section 1</u>. The above "WHEREAS" clause as shall be incorporated by reference herein.

<u>Section 2</u>. The Town Board hereby adopts a negative declaration in the form attached to this resolution and incorporated herein finding that the sale of the Town Property will not have significant adverse environmental impacts and that no Environmental Impact Statement will be prepared.

<u>Section 3</u>. The Town Board hereby authorizes the Supervisor of the Town to sign a Negative Declaration Determination of Non-Significance with respect to the project; and hereby authorizes the Town Clerk to forward a copy of said Negative Declaration Determination of Non-Significance to the New York State Department of Environmental Conservation and other interested agencies.

- <u>Section 4</u>. This Resolution is subject to a permissive referendum.
