The Town Board of the Town of Stony Point convened on Tuesday, April 28, 2020 at 7:00 pm. SUPERVISOR'S REPORT

Supervisor Monaghan made the following statement:

We continue to face one of the biggest challenges in our lifetime. As a town board we continue to monitor and evaluate our response. We acquired a limited supply of face masks through the NYS Health Department that were distributed from the Rockland County office of Emergency Management to our Town. We started distributing masks to our most vulnerable residents, our senior citizens, volunteer food pantry workers and our disabled and special needs residents. This Friday we will be distributing masks to Stony Point Residents. The distribution will be at Charles Eccher Lowland Hill Park, from 9-10:30am while our limited supply lasts.

The terrible news is that we have lost 13 residents to the Covid-19 virus. According to NYS there are currently 350 confirmed cases here in Stony Point.

I must commend our First Responders who continue to answer the call. I also want to thank and commend our essential workers. Our town employees have been working split shifts to keep everyone safe during this time.

Thanked volunteers for the NR Food Pantry led my Paula Klein. Paula has a wonderful team of volunteers. Thank you to the NR Teachers Association for donating and volunteering for the food pantry as well.

As a Town we face serious financial challenges including loss of sales tax revenue. In anticipating of re-opening our business community, I have set up a local task force with the goal of re-starting local businesses. I believe that this task force can play an important role in supporting our local businesses. Our group's objective is challenging. We hope to establish practical ideas and plans that will help our businesses get back on their feet as quickly and successfully as possible. We will be following the guidelines of our County, State and Nation. I have asked private citizens who bring expertise and experience from various sectors to be a part of the task force. They have been asked to join as a private citizen and not as a representative of their respective organizations.

Police Business

Supervisor Monaghan introduced Stony Point Police Chief Brian Moore to discuss Police Business.

Retirement of Sergeant

Chief Moore announced the retirement of Sergeant Douglas Bertrand and read the following memo:

<u>PROCLAMATION-POLICE WEEK</u> – Supervisor Monaghan read the following proclamation and praised the Police Department for the great work that they do:

PROCLAMATION POLICE WEEK

WHEREAS, the Congress of the United States of America has designated the week of May 10-16, 2020 to be dedicated as "National Police Week" and May 15th of each year to be "Peace Officers' Memorial Day", and

WHEREAS, Police Officers' Memorial Day is to be dedicated to Police Officers who have died in the line of duty, and

WHEREAS, the International Association of Chiefs of Police has requested that all municipalities honor Police Officers' Memorial Day by flying all flags within the municipality at half-mast.

NOW, THEREFORE, I, Jim Monaghan, by virtue of the authority vested in me as Supervisor of the Town of Stony Point, hereby proclaim May 10th through May 16th, 2020 as Police Week in the Town of Stony Point and in honor of those Police Officers who have died in the line of duty in this Country, all flags in the Town of Stony Point shall be flown at half-mast on May 15th, 2020

I DO FURTHER call upon all our citizens to make every effort to express their thanks to our men and women who make it possible for us to leave our homes knowing they are protected by men and women willing to sacrifice their lives, if necessary, to guard our loved ones, property and government against all who would violate the law.

<u>Supervisor Monaghan</u> thanked all the EMT's on behalf of the Town for their outstanding service and dedication during this health crisis.

Kevin Nolan spoke in favor of selling the Golf Course.

Greg Julian questioned the following on the Sale of the Golf Course:

- Difference between assessment and appraisal
- Anticipated tax revenue
- Bond responsibility
- Lost revenue

Christine Silverstein questioned the opening of the Golf Course and Day Camp.

<u>Supervisor Monaghan</u> expressed uncertainty of the Pool and Day Camp opening and introduced Dave Fusco, Director of Golf to outline the protocol put in place to safely open the Golf Course this weekend (May 2, 2020)

<u>Dave Fusco</u> described the following measures that have been put in place:

- Groups reduced from foursomes to threesomes, with single occupancy carts
- Each cart will be disinfected after each use
- Pro Shop will be closed to the public
- Nonresident players will prepay with no contact of pro shop staff
- Resident players will have access to pro shop staff with and outside service counter and plexi-glass protective shields have been installed.
- Flag sticks will remain in place
- Benches and ball washers have been removed
- social distancing will be enforced at the Driving Range and parking lot to ensure no gathering of golfers.

Refund Use of Park Facilites

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present, to authorize a refund in the amount of \$50 to Brian Neary who reserved Charles Eccher Park on May 23, 2020. Due to the Covid-19 circumstances we will not be renting out the pavilions at the parks.

Approve Lease Agreement for Police Tasers

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present, to authorize Chief Moore to enter into a lease agreement with Axon Enterprise, Inc. to replace existing outdated police tasers.

Approval of Agreement with County of Rockland for Reimbursement for Counter Terrorism Training

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and unanimously carried by a voice vote of those board members present, to authorize Supervisor Monaghan to enter into an agreement with the County of Rockland for reimbursement of Law Enforcement Overtime for Counterterrorism Training. The Town will be reimbursed from the Rockland County a sum of \$3,684.41
