RESOLUTION AUTHORIZING SETTLEMENT OF A TAX CERTIOARI MATTER

WHEREAS, the Town Board of Stony Point, New York ("Town Board") in the years 2016, 2017, 2018 and 2019 made assessments of real property by the Town Assessor; and

WHEREAS, litigation was commenced by property owners seeking a review of such assessments; and

WHEREAS, the Town Board is empowered and authorized to review any proposed settlement of tax certiorari matters and reject or approve such settlements as recommended by professionals employed by the Town; and

WHEREAS, Special Counsel Feerick Nugent MacCartney, PLLC for the Village as well as the Village Assessor, William Beckmann, have approved and recommended that it is in the best interest for the Village to resolve the litigation entitled <u>Walgreen Eastern Co., Inc./155E. 49th Holding, LLC v. The Assessor, the Board of Assessors and the Aboard of Assessment Review of the Town of Stony Point and the Town of Stony Point,</u>

under Index Nos.: 032396/2016; 033050/2017; 033963/2018; and 033677/2019 for the assessment years 2016 through 2019 (the "Litigation").

NOW THEREFORE BE IT RESOLVED that:

<u>Section 1</u>. The above "WHEREAS" clauses are incorporated herein by reference.

<u>Section 2</u>. Special Counsel Feerick Nugent MacCartney, PLLC is hereby authorized to execute a Consent Order to resolve the Litigation upon the terms and conditions set forth in the settlement documents, because such settlement of the litigation is in the best interest of the Town.

Section 3. This Resolution shall be effective immediately.
