SUPERVISOR'S REPORT

Supervisor Monaghan made the following statement:

The Rockland County Times announced that they have paused the circulation of the newspaper due to the financial impacts of the Covid-19 Pandemic. I am sorry to hear that they will not be publishing the paper. They regularly covered and reported on our Town board meetings and local happenings. Town notices will now be published in the designated alternate paper The Journal News. Our Riverfront Park summer concert series continues tomorrow evening at 7PM with the cool sounds of the Street Life Serenade Band, known for their Billy Joel Experience. Last night was the first night that our local justice court could hear Town Code Violations. I attended the court hearing for Mr. Odem.
