## STONY POINT TOWN BOARD MEETING - August 10, 2021

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, August 10, 2021, at 7:00pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY. Supervisor Monaghan called the meeting to order and led the group in the Pledge of Allegiance.

Supervisor Monaghan stated that tonight's meeting was being aired on Facebook Live.

#### SUPERVISOR'S REPORT

Supervisor Monaghan reported as follows:

As I have been reporting, the proposed sale of Camp Bullowa will be up to the Greater Hudson Valley Chapter board members. Currently they have 3 camps that they are looking into selling to settle lawsuit claims, including Camp Bullowa here in Stony Point. I have had productive meetings with representatives of NYS Open Space Institute, who along with myself have contacted several conservation groups including Scenic Hudson, Orange County Land Trust, and our State Parks representatives in Albany and here in the Hudson Valley. Our goal is to work in partnership to acquire the property, preserving the land for scouting and protecting the property from future development. The property acquisition may qualify for funding from the Federal Highland Funding source available through the state. Camp Bullowa is one of the largest privately owned properties here in Stony Point and is not only vital to scouting but an important part of our towns character. Our Town Board will do everything possible to help save and preserve Camp Bullowa.

<u>Supervisor Monaghan</u> stated that we had three saves at the pool so far this year. He commended Karenanne Nigro and presented the following lifeguards with Certificates of Recognition:

<u>Supervisor Monaghan</u> continued stating that there is a severe heat wave and that the RHO Building is the Town's cooling center for any residents without air conditioning.
