My name is Ralph Heavner.

I live in Stony Point and work at 5 Wayne Avenue, Stony Point, NY.

Good evening.

Tank you Mr. Supervisor and members of the Town Board in working to save Camp Bullowa.

**Town Board Minutes** 

Camp Bullowa is in peril.

Camp Bullowa may soon be a memory.

Founded in 1946. A gift from daughters to the Rockland County Boy Scouts to honor their late mother, Emilie M. Bullowa.

In 1949 the gift expanded to a donation of approximately \$100,000.00 placed in a trust fund for the care and operation of the camp.

That trust fund is now between 3 and 3.5 million dollars.

Over the last seventy-five years, Bullowa has served hundreds of thousands of youth. Bullowa is facing extinction.

Those who swore to serve Scouting and protect its ideals and mission statement now seem to be the architects of the camp's destruction.

For a property that was repeatedly addressed as "never for sale", the Board listed the property with Cushman and Wakefield Realty.

Prospective buyers visit and tour the camp.

All a surprise to Scouting members such as Scoutmasters, Packmasters and other grass root adult leaders.

We learn that all of this was conducted in private. Few participants, sworn to secrecy.

With mergers over the years, there are now 7 counties that can decide the future of Bullowa.

Can we trust this Scout Board?

Can we trust fiduciaries who meet in secrecy and provide no information to its members? You can reach your own conclusions.

So, you ask, what can I do?

To begin, we can act locally. Place Save Camp Bullowa signs throughout our Town and County. Make phone calls. Send emails. Write letters.

Communication is key to reminding the Scout Board that the Camp is important to you and our community.

Instead of selling camps, raise funds. Use trust monies. Establish partnerships with open space non-profits. Be a fiduciary.

Selling Scout camps is like the Little League selling its baseball fields.

In a world where daily events make us wonder whether the world really may be upside down, pay attention. Be involved.

Support Scouting.

Support Open Space.

Save Camp Bullowa.

WHEREAS, within the Town Board for the Town of Stony Point, New York ("Town Board") there is a need to protect the public health and safety from time to time with regard to the enactment of Local Laws pursuant to the powers of the municipality under the Municipal Home Rule Law, and

WHEREAS, certain events have brought to the attention of the Town Board the need to further protect public health, safety and welfare with regard to the enactment of a Local Law pursuant to the aforementioned statutory powers; and

WHEREAS, the Town Board after due deliberation, finds it in the best interest of the Town to adopt said Local Law.

NOW, THEREFORE, BE IT RESOLVED, that the adoption of the introductory Local Law entitled "Local Law Prohibiting Smoking and Vaping on Town Property" is a Type 2 and is determined not to have a significant effect on the environment.

- <u>Section 1.</u>All "Whereas" clauses are hereby incorporated by reference as though set forth in full herein.
- <u>Section 2.</u> That the introductory Local Law entitled "Local Law Prohibiting Smoking and Vaping on Town Property" be and hereby is adopted as Local Law No. 5 of 2021 of the Town of Stony Point on July 13, 2021.
- <u>Section 3.</u> The Town Board hereby directs the Town Clerk to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Stony Point, and to give due notice of the adoption of said Local Law to the Secretary of State of New York and to take all steps to process and file said Local Law amendment with the State of New York.

<u>Section 4.</u> This Resolution shall be effective immediately.

### LOCAL LAW NO. 5 OF 2021 A LOCAL LAW PROHIBITING SMOKING AND VAPING ON TOWN PROPERTY

BE IT ENACTED by the Town Board of the Town of Stony Point, Rockland County, New York ("Town Board") as follows:

#### **Section 1**. Purpose and Intent.

The Town of Stony Point recognizes that there is a continuing need to protect the health, safety, and well-being of the residents of the Town of Stony Point, by prohibiting smoking and vaping on certain Town properties and Town Parks. This local law fosters and perpetuates that protection by its prohibition of smoking cigarettes, cigars, electronic cigarettes (commonly referred to as e-cigarettes) and similar devices. It is the intent of this local law that such conduct be prohibited unless otherwise designated by the Town Board.

#### Section 2. Authority.

This chapter is enacted pursuant to the authority of Article 13E of the Public Health Law of the State of New York. It is further enacted pursuant to the authority of the Municipal Home Rule Law of the State of New York.

#### Section 3.

A new chapter, Chapter 179, shall be added to the Town Code entitled "Prohibition, Smoking and Vaping" and shall read as follows:

Chapter 179 Prohibition, Smoking and Vaping

§ 179-1. Except where approved or otherwise designated by the Town Board, it shall be unlawful for any person to smoke on any Town property within the Town which has been posted by order of the Town Board with signs prohibiting such conduct.

#### § 179-2. Penalties for Offenses

A violation of this chapter shall constitute a violation, and any person so convicted shall be subject to a fine of not more than \$500.00 .

#### Section 4. SEQR.

The Local Law prohibition of smoking or vaping on Town property shall be a Type 2 action under SEQR.

#### **Section 5**. Validity.

The invalidity of any provision of this Local Law shall not affect the validity of any other portion of this Local Law which can be given effect without such invalid provision.

#### Section 6. Effective Date.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State.

- <u>Section 4.</u> This Resolution shall be effective immediately.

#### **LOCAL LAW NO. 6 OF 2021**

## A LOCAL LAW OPTING OUT OF ALLOWING RETAIL CANNABIS DISPENSARIES AND/OR ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS WITHIN THE TOWN OF STONY POINT

BE IT ENACTED by the Town Board of the Town of Stony Point, Rockland County, New York ("Town Board") as follows:

#### **Section 1**. Purpose and Intent.

It is the intent of this local law to opt the Town of Stony Point out of hosting retail cannabis dispensaries and/or on-site cannabis consumption establishments within its boundaries.

#### **Section 2**. Authority.

This Local Law is adopted pursuant to the provisions of Cannabis Law § 131, which expressly authorizes cities and villages to opt-out of permitting retail cannabis dispensaries and/or on-site cannabis consumption establishments to locate and operate within their boundaries.

<u>Section 3.</u> Local Cannabis Retail Dispensary and/or On-Site Consumption Opt-Out
The Town Board hereby opts-out of licensing and establishing cannabis retail
dispensaries and/or cannabis on-site consumption establishments within Town
boundaries.

#### Section 5. Severability.

If a court of competent jurisdiction determines that any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this Local Law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### **Section 6**. Code Preparation.

The Town's Code preparation contractor is authorized, without further action of the Town Board, to correct typographical errors, numbering and other related technical changes that do not affect or alter the substantive provisions of this local law.

#### **Section 7.** Effective date.

This Local Law shall be effective immediately upon filing with the Secretary of State. Pursuant to Cannabis Law § 131, this Local Law is subject to a permissive referendum and thus may not be filed with the Secretary of State until the applicable time period has elapsed to file a petition or referendum has been conducted approving this local law.

**WHEREAS**, the Town Board previously authorized the Town Supervisor to execute a Purchase and Sale Agreement and Rider ("Agreement") regarding the sale of Town Tax Lots 19.02-1-1.1, 14.04-1-26 and 19.02-1-3 ("Property"); and

**WHEREAS**, as a result of a resident petition, the approval of such sale must be placed on an election ballot; and

**WHEREAS**, the Town desires such ballot proposal to be placed on the general election ballot in the Town as part of the November 2, 2021 general election.
