The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, August 14, 2018 at 7:00 pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY. Supervisor Monaghan called the meeting to order

OPEN MEETING

<u>Supervisor Monaghan</u> announced that the meeting would be opened and closed in memory of George Neumann who recently passed away. George was a resident of Stony Point for over 50 years. He was a coach in the community as well as a physics teacher. He also served the residents by being a member of the Architectural Review Board.

Supervisor Monaghan led the group in the Pledge of Allegiance.

PUBLIC INPUT

<u>Kathy LeRoy</u>-Easton Street, Stony Point spoke about the Memory Walk that is being installed at the Stony Point Dog Park. Bricks are being sold for \$50 and they can be personalized with a message for your pet. You can contact Lily Ann Wilson for more information or to reserve a brick. She also spoke about the Youth Squad with the ambulance corp. and advised that EMS training and driving is available.

<u>Supervisor Monaghan</u> said that the information can be found on the town's website. He also informed residents that the Veterans Banner program has been an overwhelming success and it will reopen in the spring of 2019.

<u>John Wynohradnyk</u>-31 Dickens St., Stony Point advised that he was speaking for the neighborhood regarding the ongoing situation at 29 Dickens St., mainly the several extremely large (mansion) parties being held at that location during the past two/three years and especially the most recent one within the past two weeks.

<u>Supervisor Monaghan</u> responded indicating that the following actions were taken along with the Stony Point Police Department's ongoing investigations:

- Our Building Department issued two notices of violations:
 - Operating a commercial business in a residential zoning district. Promotion of an outdoor music event with associated charge (fee) in violation of the certificate of occupancy for said premises, (single family dwelling).
 - Use of property for a mass gathering there by creating a hazard to the public peace and comfort and to hinder the most appropriate use of land in the vicinity.
- The Rockland County Health Department was also contacted and issued notice for:
 - $\circ\,$ Preparing food/service of food and drink to the public at a residence.
 - Use of a residential swimming pool by the public without a permit.

Supervisor Monaghan continued:

After witnessing the July 28th incident, I do believe that our Police Department handled this event appropriately and professionally and helped to alleviate a volatile situation. I have faith that our Police Department will do everything legally within their power to stop

this type of incident from occurring again. I wish that I could guarantee that no future incidents will occur, however, I am confident that our Police Department is monitoring the situation and taking all legally preventive measures that they can.

<u>Tracy Kelly</u>, 38 Dickens St. also spoke about the same concerns regarding these parties.

Brian Nugent, Esq. spoke indicating that the best way to handle this would be to create a "nuisance party local law".

Conversation developed between all the Board members and various people from the audience regarding the situation.

<u>George Potonavic</u>-597 Old Gate Hill Rd. spoke against the proposed development on the waterfront.

Susan Figueras-187 Mott Farm Rd. spoke against the proposed development on the waterfront.

TOWN OF STONY POINT

LOCAL LAW NO. 4 OF 2018

AMENDING CHAPTER 112, SECTION (6)(A) OF THE TOWN CODE OF THE TOWN OF STONY POINT, NEW YORK

A LOCAL LAW to amend Chapter 112, Section (6)(A) of the Town Code of the Town of Stony Point, Rockland County, New York, pursuant to Section 10 of the Municipal Home Rule Law of the State of New York.

BE IT ENACTED AS FOLLOWS:

Section 1. Authority

This Local Law is adopted pursuant to Section 10 of the Municipal Home Rule Law of the State of New York.

Town Board Minutes August 14, 2018 Section 2. Title and Purpose

This Local Law shall be known as "Local Law No. 4 of 2018."

The purpose of the proposed Local Law is to amend Chapter 112, Section (6)(A) entitled "Basis for establishing areas of special flood hazard" to allow the utilization of the Advisory Base Flood Elevations set forth on Flood Hazard Maps dated March 27, 2018, which set forth accurate and current estimates of future flood elevations for the Ba Mar Manufactured Home Community.

Section 3. Amendment

(4)

Chapter 112, Section (6)(A) of the Town Code is hereby amended to add § 112(6)(A)(4) and shall read as follows:

§ 112(6)(A). Basis for establishing areas of special flood hazard.

Notwithstanding the provisions of subsections (1), (2), and (3), above, with respect to the real property identified on the Town of Stony Point Tax Map as Section 20.02, Block 11, Lot 7.1 and 9, the areas of special flood hazard are identified on the "Revised Base Flood Elevation Map" dated March 27, 2018 prepared by Brooker Engineering PLLC, and the documents supporting said Map.

Section 4. Repeal, Amendment, and Supersession of Other Laws

All other Resolutions, Ordinances or Local Laws of the Town of Stony Point, which conflict with the provisions of this Local Law are hereby superseded or repealed to the extent necessary to give this Local Law full force and effect.

Section 5. Severability

If the provisions of any article, section, subsection, paragraph, subdivision or clause of this Local Law shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this Local Law.

Section 6. Effective Date

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the New York Municipal Home Rule Law.

Public Hearing – Special Requirements for Manufactured Housing Communities

A public hearing had been scheduled for August 14th to consider an amendment to the Zone Code, Chapter 215, Section 21entitled "Special Requirements for Manufactured Housing Communities". A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to cancel the Public Hearing scheduled for this item and to table the item until further notice.

Set Public Hearing – Improvement To Sewer District No. 2

The following resolution was offered by Supervisor Monaghan, who moved its adoption, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present, to-wit:

RESOLUTION 2018/33

RESOLUTION OF THE TOWN BOARD OF THE TOWN OF STONY POINT, ROCKLAND COUNTY, NEW YORK (THE "TOWN") AUTHORIZING A PUBLIC HEARING UNDER TOWN LAW SECTION 202-B TO CONSIDER AUTHORIZING CERTAIN IMPROVEMENTS TO THE TOWN OF STONY POINT SEWER DISTRICT NO. 2.

WHEREAS, the Town Board (the "Town Board") of the Town of Stony Point, Rockland County, New York (the "Town") is considering authorizing certain improvements to the Town of Stony Point Sewer District No. 2, consisting of (A) the acquisition and installation of the following improvements at the Wastewater Treatment Plant: (i) two replacement rotary lobe blowers, (ii) one vertical spiral screen, (iii) three influent pumps, including removal of the existing pump and undertaking all necessary piping modifications, (iv) pump controls, and (v) lighting at the plant; (B) the acquisition and installation of one vertical spiral screen at the Beach Road pump station; and (C) all ancillary and related equipment, furnishings, apparatuses, electrical devices, hardware, wiring and improvements necessary or proper in connection with the foregoing (collectively, the "Project"); and WHEREAS, the Town's engineers have estimated that the maximum cost of undertaking the Project is \$464,239; and

WHEREAS, the Town Board now intends to conduct a public hearing in accordance with Section 202-b of the Town Law with respect to undertaking the Project at such estimated maximum cost.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby calls for a public hearing to be held at the public meeting of the Town Board to be held on September 12, 2018 at 7:00 p.m. at the Rho Building, 5 Clubhouse Lane, Stony Point, New York 10980, to consider if it is in the public interest to undertake the Project at a maximum cost of \$464,239 and to hear all persons interested in the subject thereof; and it is

FURTHER RESOLVED, that the Town Clerk is hereby directed to cause notice of such public hearing to be published and posted in the manner prescribed by law.

This resolution shall take effect immediately.

Request to Waive Permit Fees (Camp Venture)

Assessor's Seminar – Assessment Administration

Approve Resolution In Opposition to Proposed Plans for Coastal Storm Risk Management

A motion was made by Supervisor Monaghan, seconded by Councilman Basile and **unanimously carried** by a voice vote of those board members present to approve the following resolution:

RESOLUTION 2018/34

RESOLUTION IN OPPOSITION TO PROPOSED PLANS FOR COASTAL STORM RISK MANAGEMENT WITHOUT SUFFICIENT STUDY OR COMMUNITY PARTICIPATION

WHEREAS, from July 9 through July 11, 2018, the U.S. Army Corps of Engineers (US ACOE) held public meetings for the first and only time regarding it "Coastal Storm Risk Management" study (CSRM) for New York Harbor and the Hudson Valley; and

WHEREAS, four of the ACOE's proposed alternative plans (2, 3A, 3B and 4) involve outer and inner harbor barriers that almost entirely block either the Hudson River or major New York Harbor tributaries during storm events and would alter river and tributary flow patterns at all times; and

WHEREAS, two of the ACOE's alternatives propose barriers (2 and 3A) that would entirely close off the harbor and river from the Atlantic during storm events and would alter river and tributary flow patterns at all times; and

WHEREAS, the proposed barriers could impede the estuary's tidal flow, contaminant and sediment transport, and migration of fish, and impede the tidal "respiration" of the river; and

WHEREAS, over time, the barriers have the potential to 1) significantly restrict migrations of striped bass, Atlantic sturgeon, herring, shad, eel and other species essential to the Hudson estuary, 2) prevent the ocean tide from flushing NY Harbor, and 3) inhibit rainstorm flood waters like those during Irene and Lee in 2011 from leaving the Hudson.; and

WHEREAS, open tidal exchange is essential to move sediment and flush contaminants and if tidal exchange is restricted, the harbor could require much more dredging to maintain shipping channels. Sewage and other contaminants could flush to the ocean more slowly, resulting in more pollution for our already contaminated harbor and river; and

WHEREAS, proposed alternative #5 – described as "Perimeter-only" and relying entirely on shoreline-based floodwalls and levees - is the only scenario presented so far that may protect low-lying communities from storm surge from storms like Irene, Lee and Sandy, while leaving our rivers to continue to flow naturally; and

WHEREAS, the proposed plans with in-water barriers do not account for climate change and do nothing to help communities adapt to sea level rise; and

WHEREAS, insufficient scientific data is available to fully understand the consequences of altering Hudson River flow with permanent barriers; and

WHEREAS, the public comment period has been set for only five weeks during peak summer vacation times when many residents are away and not easily informed about this major set of proposals; and

WHEREAS, Scenic Hudson, Riverkeeper, and many others have voiced their concern and opposition to storm risk management approaches that could severely compromise the health of the Hudson River and its tributaries; and

BE IT RESOLVED, that the Town Board of the Town of Stony Point does hereby register its strongest possible opposition to proposed plans 2 and 3A, and asks that they be removed from further consideration; and be it further

RESOLVED, that the Town Board of the Town of Stony Point does hereby register its support for further studies to ensure that shoreline-based measures such as Alternative 5, described as "Perimeter Only", would in fact protect New York Harbor and the Hudson Valley from flooding; and be it further.

RESOLVED, that further planning to manage the risk of coastal storm damage takes into account the impact of climate change and its impact on seal level rise; and be it further

RESOLVED, that the public comment period be extended by 90 days to allow for full public understanding and response to the US ACOE proposals; and be it further

RESOLVED, that this resolution be distributed to Nancy J. Brighton, Chief, Watershed Section, US ACOE, Senator Chuck Schumer, Senator Kristen Gillebrand, Congresswoman Nita Lowey, Congressman Eliot Engel, Governor Cuomo, Secretary of State Rossana Rosado Senator Andrea Stewart –Cousins, Assemblyman Thomas Abinanti.
