STONY POINT TOWN BOARD MEETING - DECEMBER 10, 2019

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, December 10, 2019 at 7:00 pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY.

Supervisor Monaghan announced that tonight's Town Board meeting will be held in memory of Stony Point's own **Edward Kwiecinski** who passed away this week at 101 years old. Edward proudly served our Country in the United States Army during WWII as a member of the 112th Infantry Combat Team. His Unit was the second wave to hit Omaha Beach, France on July 22, 1944. Last August on Edward's 100th birthday the Town honored him with a proclamation here at a town board meeting on his birthday declaring August 10th, 2018 as Edward Kwiecinski Day in the Town of Stony Point. **WE LOST A TRUE AMERICAN HERO** and we will open and close tonight's meeting in memory of Mr. Kwiecinski.

Supervisor Monaghan called the meeting to order and lead the group in the Pledge of Allegiance.

PRESENTATION

CRIMINAL JUSTICE REFORM ACT

<u>Supervisor Monaghan</u> introduced those listed below who were present for the "Informational Meeting on the Criminal Justice Reform Act" a new bill that takes effect state-wide on January 1, 2020:

- Rockland County Sheriff Lou Falco
- President of the Rockland County Police Chiefs Association Chief Brad Weidel
- Town of Orangetown Police Chief Butterworth
- Town of Haverstraw Police Chief Murphy
- Town of Haverstraw Capt. Marty Lund
- Representing Rockland County District Attorney's Office Hon. Charles Apotheker
- Town of Stony Point Police Chief Brian Moore

This is an unfunded mandate passed by Albany. They conferred with no one prior to passing it and there are real concerns as to how this will affect public safety. It is very important for the public to be aware of the changes that will be taking affect shortly.

<u>Chief Brad Weidel</u>, President of the RC Police Chief's Association, spoke first. He indicated that the Rockland County Police Chiefs Association is not opposed to reform, but reform needs to be sensible, not abrupt and disruptive, and negatively affect the criminal justice system. He went on to point out only a few of the concerns with this CJRA; including mandatory release of criminals, discovery, defendant being able to return to the scene of the crime, diminishes the effectiveness of all our judges, and cost factors to each town, village and county involved. He also indicated that this was passed without one bit of input from any law enforcement official, judge or district attorney.

Rockland County Sheriff Lou Falco spoke and indicated that the group made an official request to all state lawmakers who cover Rockland county to enact a 90-day moratorium so these reforms can be properly discussed. No one (police chiefs – district attorneys – judges) was consulted or allowed to have input as to these changes. We are not opposed to reforms to our criminal justice system. These changes will have a significant impact on public safety and the cost will be passed down to the towns, villages and counties. The reforms were passed as part of the state budget and were not discussed on the floor of the legislature. There are now 400 crimes listed where judges have no discretion and cannot set bail. The defendants will automatically be released. Everyone is urged to contact their state representatives.

<u>Judge Charles Apotheker</u> spoke on behalf of District Attorney Elect Tom Walsh who called for an immediate moratorium on the criminal justice reform. Judge Apotheker indicated that this reform prevents judges from doing the job they were elected to do.

PUBLIC INPUT

- Rockland County Legislature Doug Jobson advised that the Rockland County Legislature is attempting to adopt legislation calling for a moratorium.
- Greg Julian 15 Ridgetop Dr., Tomkins Cove spoke about the "alienation bill" regarding the golf course.
- George Potanovic Old Gate Hill Rd., spoke about the variances being sought by Ba Mar before the Zoning Board of Appeals and the Freedom of Information process.
