RESOLUTION OF THE TOWN BOARD OF THE TOWN OF STONY POINT AUTHORIZING THE SUPERVISOR TO EXECUTE AN AGREEMENT WITH THE COUNTY OF ROCKLAND AND PARTICIPATING AGENCIES RELATING TO THE ROCKLAND COUNTY INTELLIGENCE CENTER

WHEREAS, the County of Rockland along with Participating Agencies including the Town of Haverstraw, Town of Ramapo, Village of Spring Valley, Village of Piermont, and Villages of South Nyack/Grandview are seeking to enter into an agreement share services relating to critical law enforcement issues and the Rockland County Intelligence Center ("RCIC"); and

WHEREAS, under the terms of the proposed Agreement, the Participating Agencies will maintain the RCIC, which will provide local law enforcement agencies with criminal intelligence and avoid duplication of effort and expenses by efficiently and effectively utilizing all available resources; and

WHEREAS, the Term of the proposed Agreement begins January 1, 2018 and expires December 31, 2023 and provides for the option to renew for five (5) additional one (1) year terms; and

WHEREAS, the Town Board for the Town of Stony Point ("Town Board") hereby desires to enter into said Agreement; and

NOW, THEREFORE, BE IT RESOLVED that:

- Section 1. The above "WHEREAS" clauses are hereby incorporated by reference as though set forth in full herein.
- Section 2. The Town Board hereby authorizes the Supervisor to execute the Agreement with the County of Rockland relating to the Rockland County Intelligence Center and to otherwise take necessary actions to facilitate the provisions of the Agreement.

Section 3. The Town Board hereby authorizes the Chief of Police to take necessary actions to facilitate the provisions of the Agreement and to participate in the activities of the Rockland County Intelligence Center.

Section 4. This Resolution shall be effective immediately.

WHEREAS, certain parcels of land described and depicted in Exhibit "A" have been offered for dedication to the Town of Stony Point (the "Town") for highway purposes by Jessup Ridge Estates, LLC, the owner of said land as shown on the subdivision map entitled "Jessup Ridge West" and filed on May 14, 2014 as map No. 8240 in Book 129 and page 84 of Maps; and

WHEREAS, the Highway Superintendent of the Town and the Town Engineer have reviewed the proposed dedication and have not indicated any impediments to the dedication for highway purposes, and have recommended retention of \$104,000 for a one year maintenance/repair period as recommended by the Town Engineer; and

WHEREAS, the Town has been presented with appropriate deed documents and related title documents describing all lands to be conveyed to the Town as a Town roadway.

NOW, THEREFORE, BE IT RESOLVED that:

<u>Section 1</u>. The above "Whereas" paragraphs above are incorporated by reference as if fully set forth herein.

<u>Section 2</u>. The Town hereby accepts the dedication of the property described in Exhibit "A" as Town roadway and directs the Town Clerk to file or cause to be filed by the applicant any and all necessary documents in the Rockland County Clerk's Office.

<u>Section 3</u>. The Town Clerk, Town Engineer, and Town Special Counsel are hereby authorized and directed to take any and all necessary actions to carry out the provisions of this Resolution.

<u>Section 4</u>. The Town Supervisor and the Town Highway Superintendent is hereby authorized to execute any and all documents necessary to carry out the provisions of this Resolution.

<u>Section 5</u>. This Resolution shall be effective immediately.

Refer Skate Park Preliminary Design to ARB

WHEREAS, the Town Board for the Town of Stony Point ("Town Board") desires to retain McGiff Halverson, LLP to provide legal services and representation to demand a defense under the Town's Public Entity Management Liability Policy from Travelers' Insurance: and

WHEREAS, Travelers previously denied the Town's request for defense and indemnification in the <u>Matter of Phillips, et al. v. Town of Stony Point, et al.</u> (Index No.: 000339-2018; and

WHEREAS, the Town Board has reviewed Travelers denial and desires to retain legal counsel to demand a defense from Travelers in said proceeding; and

WHEREAS, the Town Board deems it necessary to secure legal counsel through Travelers as there may be significant cost savings to the Town.

NOW, THEREFORE, BE IT RESOLVED that:

- <u>Section 1</u>. The above "WHEREAS" clauses are hereby incorporated by reference as though set forth in full herein.
- Section 2. The Town Board hereby authorizes the Supervisor to execute a retainer agreement with McGiff Halverson, LLP and to otherwise take necessary actions to further the purposes of this Resolution in an amount not to exceed \$7,500 without further Board approval.
- Section 3. This Resolution shall be effective immediately.
