STONY POINT TOWN BOARD MEETING - May 14, 2019

The Town Board of the Town of Stony Point convened in Regular Session on Tuesday, May 14, 2019 at 7:00 pm at the Stony Point Community Center (Rho Building), 5 Clubhouse Lane, Stony Point, NY.

Supervisor Monaghan announced that the meeting would be opened and closed in loving memory of **Francis Michael "Mickey" Dorsey**. Mickey was a member of the United States Army during World War II and at the age of 18 landed with his Unit (the 225th Search Light Battalion) on Omaha Beach in Normandy, France. Mickey and his Unit, served with honor and distinction, and were credited with destroying thirty-nine enemy aircraft. In 2014 he was honored by the Country of France for his efforts during the War by receiving France's highest award, "The Legion of Honor." Mickey, being the extraordinary person he was, continued to serve his community, the Town of Stony Point, with honor and distinction his entire life, being instrumental in bringing a 9/11 Monument to Stony Point and the establishment of monuments to honor Veterans of all wars. Right up to 2018, he participated in the Memorial Day Parade each year, usually marching with the honor guard. Stony Point lost a true hero with his passing at age 94 on May 6, 2019.

<u>Stephen Beckerle</u>-49 Beach Road thanked the board for their ongoing work attempting to get the Letchworth property developed. Asked the board to be patient and involve the residents in the sale. He also addressed the major litter issue in the town. Asked that the police dept enforce fines for littering. He commended the planning board and Bill Sheehan for their efforts.

CONVEYING THE INTENT OF THE TOWN OF STONY POINT TO EXPRESS CONDOLENCES TO, AND SUPPORT FOR THE FAMILY OF PAULA BOHOVESKY, WHO WAS BRUTALLY RAPED AND MURDERED THIRTY-NINE YEARS AGO, AS PAULA'S FAMILY ASKS THE NEW YORK STATE PAROLE BOARD NOT TO RELEASE HER KILLERS

WHEREAS, the Stony Point Town Board wishes to express its continuing condolences to, and support for, the family of Paula Bohovesky, who was brutally raped and murdered thirty-nine years ago, as Paula's family asks the New York State Parole Board not to release her killers; and

WHEREAS, in 1980, Paula Bohovesky was a talented artist, an aspiring actress and a well-regarded member of the junior class at Pearl River High School; and

WHEREAS, this young woman, burgeoning with energy and a zest for life, was tragically and senselessly murdered just two blocks from her home; and

WHEREAS, the two young men who committed this heinous crime after a day spent drinking in a local bar received the maximum penalty for murder then allowed in New York State, twenty-five years to life in prison; and

WHEREAS, Paula's family and friends, as well as those living in Rockland County at the time, can still recall the horror of that day; and

WHEREAS, Paula's mother, Lois Bohovesky, must again relive that day as she fights to keep Paula's killers in jail by asking the Parole Board not to authorize the men's release, a task that she will have to often undertake because state law allows inmates seeking parole to reapply every two years; and

WHEREAS, the murderers of Paula Bohovesky are again eligible for parole and are seeking release from prison; and

WHEREAS, the Stony Point Town Board has met, considered and by a unanimous vote approved this resolution; now, therefore, be it

RESOLVED, that the Stony Point Town Board wishes to express its continuing condolences to, and support for the family of Paula Bohovesky, who was brutally raped and murdered thirty-nine years ago, as Paula's family asks the New York State Parole Board not to release her killers.

RESOLUTION 2019/21

RESOLUTION AUTHORIZING HOME RULE REQUEST ON BEHALF OF THE TOWN OF STONY POINT REGARDING NEW YORK STATE SENATE BILL \$5281A and NEW YORK STATE ASSEMBLY BILL A7610

WHEREAS, in 1974, the State of New York conveyed to the Town of Stony Point ("Town") a parcel of land identified on the Tax Maps as Parcel 14.04-1-26 which includes the Town of Stony Point Recreational Ballfields as well as a portion of the Patriot Hills Golf Course; and

WHEREAS, the Town of Stony Point desires to retain the recreational ballfields parcel, but desires the ability to eventually convey the portion of that parcel currently constituting part of the Patriot Hills Golf Course (hereinafter "Subject Parcel"); and

- WHEREAS, the Subject Parcel at the time of its conveyance included a requirement that the parcel be used for public recreational purposes with a reverter clause to the State of New York in the event that such parcel was not used for recreational purposes; and
- **WHEREAS**, the conveyance of the Subject Parcel would be deemed an alienation of certain parklands requiring State Legislative approval; and
- **WHEREAS**, the Town Board of the Town desires to continue the use of the Subject Parcel as a golf course open for use by the residents of the Town; and
- **WHEREAS,** a Bill to facilitate such alienation of the public property has been introduced in the New York State Senate as Bill No. S5281A; and
- **WHEREAS,** a Bill to facilitate such alienation of the public property has been introduced in the New York State Assembly Bill No. A7610; and
- **WHEREAS**, the Town Board desires to express its support of such Bills to accomplish the Town's objectives.

NOW THEREFORE BE IT RESOLVED that:

- <u>Section 1</u>. The above "WHEREAS" clauses are Incorporated herein by reference.
- Section 2. The Town Board of the Town of Stony Point hereby authorizes the Town Supervisor and Town to take any and all actions necessary to prepare and file the Town Home Rule request for Senate Bill No. S5281A and Assembly Bill No. A7610.
- <u>Section 3</u>. As indicated by the vote herein, the Town Board supports this request.
 - Section 4. This Resolution shall be effective immediately.

Police Candidate Nomination
